Coleman's Comments

It is July and we are well into our construction season. Our Traffic Department has inspected signs for reflectivity and replaced signs as needed. They have been moving ahead of the Highway Department and contractors to place appropriate construction signage and barricades. They have begun traffic counts for all county roads and bridges this year.

The Highway and Ditch Departments have been busy spraying and mowing ditches and roadsides to control growth and provide for adequate sight distance. They have been cleaning and repairing tiles and will be trimming and spraying around signs and guardrail throughout the summer. We have been replacing culverts in advance of the resurfacing projects, grading roadside ditches, trimming brush, and chip-sealing roads.

The Bridge Crew has replaced four structures so far this year. Two of these structures had been closed to traffic prior to replacement and one other could not be crossed by school buses. They are currently replacing a structure on Township Road 157 in Zane Township. After that, we plan to move to County Road 2 for the emergency replacement of a culvert that was destroyed by a combination of flooding and detoured traffic during the closure of State Route 292.

Our office staff has been very busy preparing plans and bid documents for these projects as well as the contract services that we have bid this year. We have prepared such documents for County Resurfacing, Township Resurfacing, Township Chip-Seal. County Rejuvenation, County and Township Pavement Markings, and the Buckeye Avenue Reconstruction Project. We have been working on developing a plan to remove log jams and debris from the Great Miami River with the County Commissioners, the Soil and Water Conservation District. and concerned citizens. We have been addressing several flooding concerns with villages and private property owners due to heavy rains that we experienced in June. We have reviewed several subdivision plats and stormwater and erosion control plans for developments.

This year we will be completing a very aggressive sealing program on the county highway system. We will complete

nearly 77.5 miles of sealing this year. Most of this work will be completed by the County Highway Department utilizing chip-seal with hot tar and stone chip surface. This seals the surface of aged asphalt to protect the roadway from water penetration which will help us to extend the pavement life. The stone chips provide friction for vehicle control and braking. Immediately after the application of new chip seal, loose stone and dust will be present. We encourage drivers to slow their travel speed and use caution until the loose stone has been removed by traffic and sweeping. Motorcycles require additional caution when traveling on recently sealed roads. We encourage drivers to report any areas of excessive loose stone so that we can schedule sweeping as soon as possible.

We are using two new products for a portion of our sealing program this year. They are asphalt rejuvenators and they are designed to reintroduce oils into the asphalt that are lost due to the manufacturing process of hot mix asphalt and aging of the pavement. These oils and resins are designed to return flexibility to the pavement and help reduce cracking, which will help us extend the pavement life. One product is Reclaimite which has been applied to CR 11, 32, 130, and a small test strip on CR 2 by Pavement Technologies, Inc. The other product is Soy Seal, a soybean based product, which will be applied to CR 66 and a small test strip on CR 2 by Freisthler Paving, Inc. We will be monitoring the performance of these products over the next several years.

The Map Room and the Building Authority have also been very busy with their normal activities. I encourage everyone to visit our fair booth in the Merchants Building at the Logan County Fair for additional information regarding this years projects.

I would like to note that we have been unable to update our website for some time due to a change of internet service providers and lightning damage that we have experienced. We are still attempting to correct these problems and will be updating our site as soon as possible and ask for your patience during the interim.

2004 ROAD PROGRAM

We have been hard at work already this year planning for next years' road program. We have reviewed each road on the program for needed culvert replacements, bridge replacements and/or repairs, drainage problems, where widening is needed, etc.

As of March 24, 2004, the road program is as follows:

2004 BRIDGE PROGRAM

In the renewing of the sales tax for roads and bridges, the priority is based on condition. Therefore, the 2004 bridge program continues the commitment of prioritizing bridge replacements based on condition. The County infrastructure will be re-evaluated periodically and changes to this program are likely to occur in order to achieve our commitment to repair or replace the structures and highways in the worst condition first.

A MESSAGE FROM OUR HIGHWAY GARAGE CREWS Work Zone Safety


Many times our job requires us to use a rolling type flagging operation. This means the work area is always on the move. As you travel through this area be aware of traffic that sometimes enters from private drives. This can be dangerous if they enter your lane. So always be prepared to stop and travel at a safe speed. Once clear of the work area, proceed in the proper lane as directed by the flagger.

Heed warning signs such as one lane road and workers ahead signs. Be prepared to slow down or stop. Also, watch for loose stone or other obstacles. Do not drive in fresh laid tar. Besides getting it all over your car, it is very slippery and you could lose control of your vehicle.

Watch out for tractors mowing the road ditches. They have to enter the roadway many times to go around signs, mailboxes and other obstacles, while watching out for holes or other hazards in the ditches. They could possibly not see you. After all , they are only human and we have to watch out for each other and do everything we can to keep each other safe. Be on the look out for flying objects that come out from under the mowers. Sometimes they land on the road, so give them some room when passing.

Just be patient and prepared and travel at a safe speed and all should be fine.
