Bidders must be ODOT Pre-Qualified. The Contractors and Subcontractors performing the work item must be Pre-Qualified in: Clearing and Grubbing; Roadway Excavation and Embankment Construction; Temporary Soil Erosion and Sediment Control; Aggregate Bases; Flexible Paving; Concrete Texturing; Level 2 Bridge; Reinforcing Steel; Structural Steel Erection; Stud Welding; Structural Steel Painting; Expansion \& Construction Joints, Joint Sealers, Bearing Devices; Caissons/Drilled Shafts; Drainage (culverts, misc.); Guardrail/Attenuators; Misc. Concrete; Maintenance of Traffic; Waterproofing; Signing; Pavement Markings; Landscaping; Trucking; Sealing of Concrete Surfaces with Epoxy or Non-epoxy Sealers.

Disadvantaged Business Enterprises (DBE) participation project goals (subcontracts, materials, supplies) have been set for this project at $10 \%$ for those certified as DBEs in accordance with 49 CFR, Part 26, and qualified to bid with ODOT under chapter 5525 of the Ohio Revised Code. The contractor is responsible for all DBE requirements including but not limited to: Adherence to Proposal Note 13 (PN013), Submission of C-92 sublet form(s) and Incorporation of FHWA 1273 into sublet-agreements.

All work, disputes, change orders and termination shall comply with the State of Ohio Department of Transportation Construction and Material Specifications dated January 1, 2019.

Bids will be furnishing all labor, equipment, and materials.
Bids shall be unit price and total price.
As specified in Ohio Revised 153.54, a bidder must submit a bid guaranty in the form of either (1) a bond for the full amount of the bid or (2) a certified check, cashier's check, or letter of credit in the amount of $10 \%$ of the bid. The Logan County Commissioners and Ohio Department of Transportation are to be named as obliges.

Bidders shall comply with the provisions of the Americans with Disabilities Act of 1990.
Bids will be awarded to the lowest and best bidder.
The Board of Commissioners reserves the right to reject any or all bids and to waive any defects in the bids.
