Re: PID #115980 - TR 179 Widening & Resurfacing: Apparent Low Bidder Results

Dear Trustees:

On May 14, 2024, at 10:00 A.M. one bid was received for the subject project and the bid amount from Shelly Company-Northwest was \$196,858.45. The Engineer's Estimate for the project was \$166,210.83. Per Ohio Revised Code 153.12, this bid is within the allowable 20% awardable bid threshold.

Total funding secured for this project is \$150,802.81. Thus, the township would need to appropriate at least \$46,055.64 to make up the difference between the low bid and available funding. Please keep in mind that change orders may be required during construction thus we recommend the township allocate an additional 10% (\$50,661.21 total) to cover potential change orders.

This project application was submitted in August 2021 for an estimated total cost of \$109,201.00 (with a local match of \$10,920.00). Since then, we've applied for and received two additional funding increases to make up for the rapidly rising costs of construction that have continued since we created the initial estimate. The small size of the project also led to higher-than-predicted pricing.

In consideration of the benefit of this project and the funding available, I strongly encourage the township move forward with this project. If you would like to move forward with this project, please send us (1) a certification of the appropriation of local funds for \$50,661.21 and (2) a resolution approving of the appropriation of local funds and a statement saying the trustees would recommend the Logan County Commissioners accept the Shelly Company-Northwest bid proposal received on May 14, 2024, at 10:00 A.M. for \$196,858.45 for PID #115980 – TR 179 Widening & Resurfacing.

If you would not like to move forward with this project, please send us a resolution stating the trustees would recommend the Logan County Commissioners reject the Shelly Company-Northwest bid proposal received on May 14, 2024, at 10:00 A.M. for \$196,858.45 for PID #115980 – TR 179 Widening & Resurfacing.
