## Gentlemen:

I have reviewed the bids received on January 23, 2025, for the above captioned materials shown on our bid specifications. Attached is a tabulation of the bids received by your honorable board. I offer the following comments concerning the bids:

- 1. Asphalt Materials is low bidder for HFRS-2P, and the only bidder for Fog Seal (QF-40 or Equal), and HFMS-2.
- 2. Marathon Petroleum Co. was not the low bidder on any single item.
- 3. Shelly Materials is low bidder on 301, 448-T1 and 448-T2 Hot Mix
- 4. Hei-Way LLC was the high and only bidder for HPM Cold mix with a 24 ton minimum order

In view of the above, I recommend that your honorable board accept all of the bids, authorizing us to buy from the lowest bidder for each grade of the material, and to purchase product from an alternate bidder, if the low bidder is unable to supply us with material on any given quantity, day, and time. This will allow us flexibility, depending on material and aggregate to be used on various projects.

These materials will be purchased from Auto and Gas Funds.

In accordance with ORC 9.24, we have checked the Auditor of State's Unresolved Findings for Recovery Database and the federal system for awards management. All companies that bid were not listed and we have retained the certified search confirmation page in the project file.
