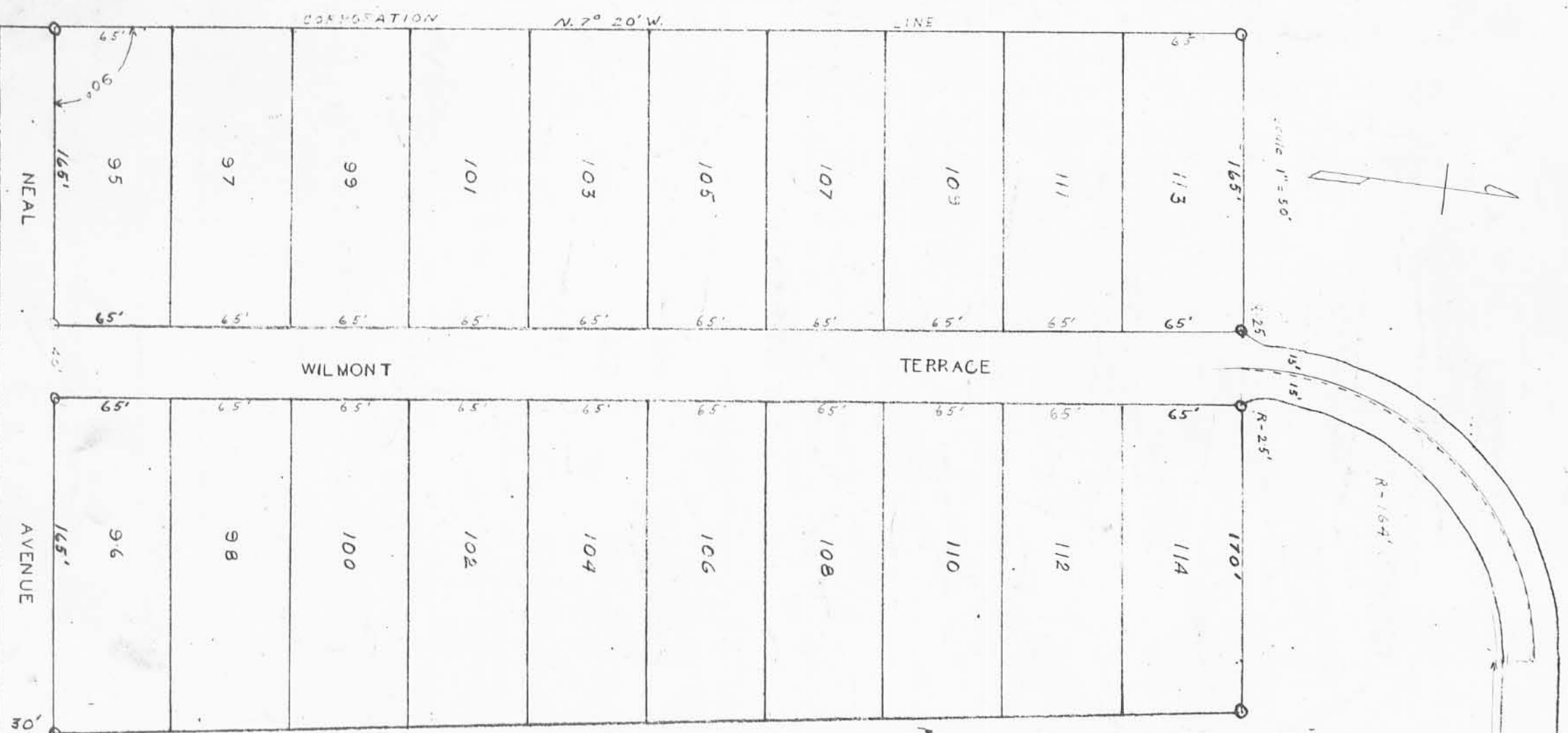


WRENS ALLOTMENT IN THE VILLAGE OF HUNTSVILLE, OHIO

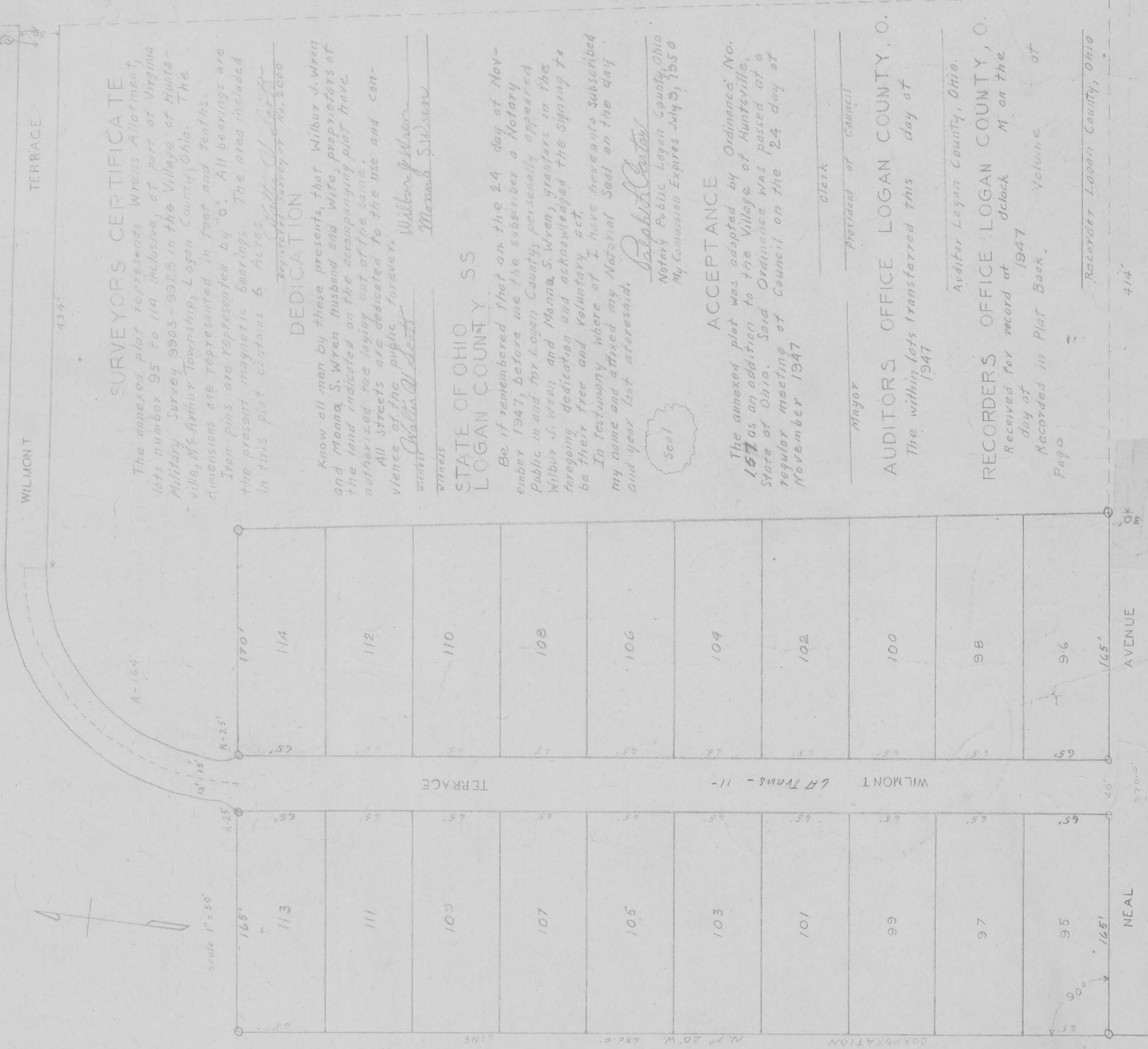
