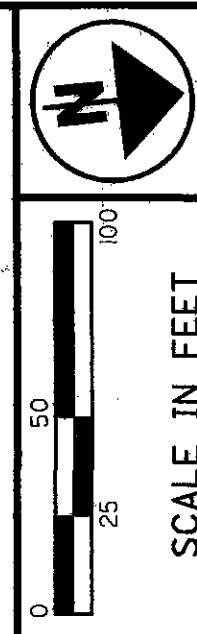

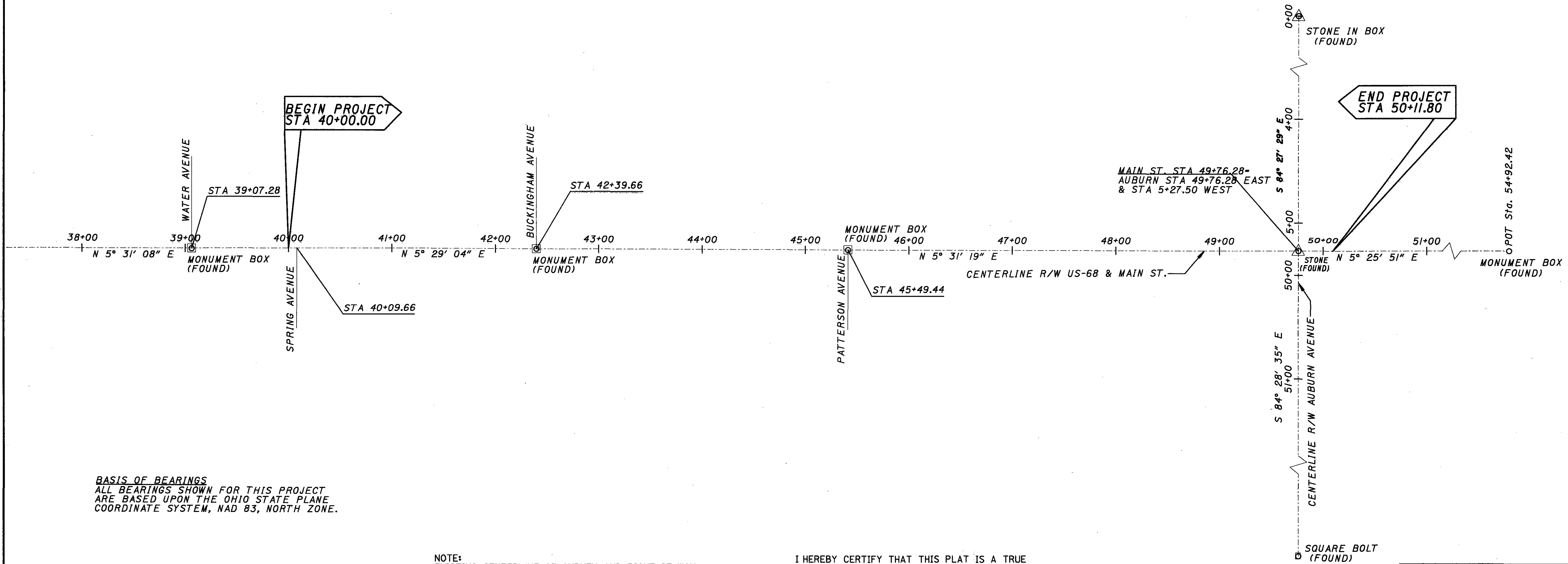
RIGHT OF WAY PLAN
