


Plat Cab. A, Slide 159

The annexed diagram represents the town plat of Huntsville surveyed September the twenty ninth 1846, by George Hoover, our surveyor No. 2904, Lima and 2nd streets are each 30 feet wide, all other streets are sixty feet wide each, all the alleys are each 16 1/2 feet wide, lots nos 1 to 23 except 15 and 16 are each 4 poles by 8 poles, (lot 15 is 4 poles wide and 14 feet on Lima Street, 4 poles 9 1/2 feet on Napoleon Street, 6 x 8 inches on East line and 4 poles on North line, lot no 16 is 6 poles wide on West line, 4 poles 7 1/2 feet on Napoleon Street, 7 poles 14 ft on East line and 4 poles on North line, a stone planted at N. W. corner of lot no 1, Lima Street bears N. 10° 36' W. all other streets and alleys parallel and at right angles with it, lot 24 is 1 pole 4 feet inches on East side and 6 poles on South East side and 6 poles 12 feet on South side, all other sides equal to full lots.

Lots 4 to 16 inclusive are on Thomas Wicks land, A. A. Harrison, C. S. L. C. O.
The other lots are on G. Hoover land.






The alley is 16 1/2 feet wide. Lots No. 21-22-23-24-25-26 and 27 are each 4 by 8 poles containing 32. perches. Lot No. 27 contains 22 1/2 perches and has its length expressed on its lines. Lot No. 28 contains 38 perches. A stone is planted at the N. W. Corner of lot No. 21.

Note: The lots are numbered from 21 to 28 to correspond with the Nos. in the first Eastern Addition to the town of Huntsville.
