



#### NANCY S. HURLEY SURVEY 0.207 ACRE July 16, 2006

Thence South 0°03'52" West 83.22 feet, departing from the south line of Watson Way (16.5 feet wide alley), following the west line of said 0.410 acre tract, the east line of said Tract I, the east line of said Tract II, the east line of said Tract IV, and the east line of said Tract V, crossing Lot 137 and entering Lot 138, to a square head spike found;

Thence **South 89°55'51"** West **49.74 feet**, continuing along the west line of said 0.410 acre tract and following the south line of said Tract V, to a magnetic nail set in the east line of Citizens Federal Savings & Loan Association of Bellefontaine's tract (part of Lot 138) described in Official Record Volume 39, page 613;

Thence North 0°03'52" East 1.12 feet, following the east line of said Citizens Federal Savings & Loan Association's tract and the west line of said Tract V, to a point in the south line of said Tract IV;

Thence North 89°54'03" West 59.12 feet, following the north line of said Citizens Federal Savings & Loan Association's tract and the south line of said Tract IV, to a chiseled 'X' set in concrete in the east line of North Main Street and in the west line of Lot 138;

Thence North 0°00'00" East 82.25 feet, following the east line of North Main Street, the west line of Lot 138, the west line of Lot 137, the west line of said Tract IV, the west line of said Tract III, the west line of said Tract II, and the west line of said Tract I, to the place of beginning, containing 0.207 acre, more or less, and subject to all valid



easements and restrictions of record.

Of the above-described 0.207 acre tract of land, 0.048 acre is all of Tract I, 0.056 acre is all of Tract II, 0.051 acre is all of Tract III (of which 0.034 acre is part of Lot 137 and 0.017 acre is part of Lot 138), 0.051 acre is all of Tract IV, and 0.001 acre is all of Tract V.
