

The following described land being in V.M.S. 4990 and being in the City of Bellefontaine , Lake Township, Logan County Ohio.

Tract No. I

Beginning at an iron pin at the intersection of the center line of East Sandusky Ave. and the Center line of Hayes St. Thence with the center line of Hayes St. S. 4 - 01 W. 427.6 feetto an iron said iron being at the S.W. corner of Donahue land and said iron being the beginning point of this surveythence with said Donahue S. lineN.87 - 36 E. 349.0 feet to an iron pipethence S. 3 - 29 W. 155.9 feet to an iron said iron being in Longbrakes N.E. corner the last described line passing an iron at Blairs N.W. corner at 120.1 feet thence with Longbrakes N. line S. 88 - 35 W. 166.7 feet to a post and S. 87 - 27 W. 183.5 feet to an iron in the center line of Hayes St. thence with the center line of Hayes St. N. 4 - 01 E. 154.1 feet to the place of beginning excepting from the above, 25 feet off of the West end said 25 feet being the East half of Hayes St. (Hayes St. being a 50 foot St.) said tract containinf 1.14 acres more or less (Said 1.14 acres does not include any of the land in Hayes St.)

Tract No. 2

Beginning at an iron pin at the intersection of the center line of E. Sandusky Ave. and the centre line of Hayes St. thence with the center line of E. Sandusky Ave. N. 73 --18 E. 374.7 feet to a point at the N.E. corner of Hughes land said point being the beginning point of this survey thence with Hughes E. line S. 4 --48 W 364.6 feet to an iron pipe at Hughes S. E. corner and Donahues N. E. corner thence S. 3 - 37 W. 156.0 feetto an iron pipe at Donahues S.E. corner and also being the N.E. cor ner of Tract No. 1 herein described thence S. 3 - 29 W. 120.1 feet to an iron at Blairs N.W. corner thencewith Blairs N. line S. 86 - 05 E. 264.7 feet to an iron at Weimers S.W. corner thence with Weimers W. line N. 5 -50 E. 747.8 feet to a point in the center line of E. Sandusky Ave. thence with the center of Sandusky Ave. S.73 - 18 W. 304.9 feet to the place of beginning excepting from the above 30 feet off of the N. end said 30 feet being the S. half of Sandusky Ave. (E. Sandusky Ave. being a 60 foot St. ) said tract containing 4.18 acres more or less (said 4. 18 acres does not include any of the land in Sandusky Ave. )

ORDINANCE NO. 20.79

AN ORDINANCE VACATING THAT CERTAIN PUBLIC EAST-WEST ALLEY OF RITTER ALLOTMENT BETWEEN LOTS 3529-3531 ON THE NORTH AND LOT 3532 ON THE SOUTH, IN THE CITY OF BELLEFONTAINE, LAKE TOWNSHIP, LOGAN COUNTY, OHIO, AND DECLARING AN EMERGENCY IN SAID CITY.

WHEREAS, a petition by Craig Poeppelman, owning lots in the immediate vicinity of the hereinafter described alley was duly presented to Planning Commission and Council praying that the hereinafter described alley be vacated; and

WHEREAS, waivers and consents to the proposed alley vacation have been filed by all abutting lot owners and notice of the intention of this Council to vacate said alley is not required pursuant to Ohio Revised Code Section 723,06; and

WHEREAS, the Planning Commission of the City of Bellefontaine has recommended that Council grant said petition; and

WHEREAS, this Council is satisfied that there is good cause for such vacation; that such vacation will not be detrimental to the general interest of the City; and, therefore, ought to be

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Bellefontaine, Ohio:

SECTION I: That 20 foot wide and approximately 230.1 foot long East-West public alley of Ritter Allotment (Plat Cabinet A, Slide 117), as more particularly outlined on Exhibit A attached hereto and incorporated herein, lying between City Lots 3529-3531 on the North and City Lot 3532 on the South, in the City of Bellefontaine, be, and the same hereby are, vacated; reserving, however, unto the City of Bellefontaine easement rights for any and all municipal purposes. Parcels # 17-092-09-18-028-000 (Part Lots 3529 and 3530), 17-092-09-18-027-000 (Part Lots 3529-3531), 17-092-09-18-026-000 (Part Lots 3530 and 3531) and 17-092-09-18-029-000 (Lot 3532).

SECTION II: That the plat accompanying said petition be referred to the Clerk of this Council for filing with the Logan County Auditor and Recorder as provided by Ohio Revised Code Sections 711.39 with any accompanying fee.

SECTION III: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of said City and to allow for said alley vacation at the earliest possible time; and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor,


