

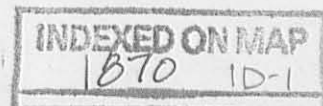

N. 89°-20' E. 30.0 feet to a point in the east property line of Main Street; thence with the East property line of Main Street North 20.0 feet to a point at the intersection of the East property line of Main Street with the North property line of Lake Avenue said point being the beginning point of this Survey; thence continuing with the east line of Main Street, North 84.0 feet to an iron pin; thence N. 89°-20' E. 150.0 feet to an iron pin in the West line of the Logan County Fair Grounds; thence with the west line of the Logan County Fair Grounds; south 84.0 feet to a point in the North line of Lake Avenue; thence with the North line of Lake Avenue S. 89°-20' W. 150.0 feet to the place of beginning containing 0.29 acres.

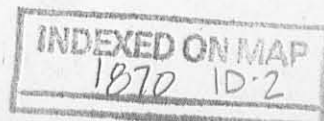

S. Johnson's 0.29 acre tract, said point being the beginning point of this survey; thence continuing with the east line of Main Street, N.  $4^{\circ}-35'$  E. 170.0 feet to an iron pin; thence S.  $86^{\circ}-03'$  E. 150.0 feet to the west line of Logan County Fair Grounds; thence with the west line of the Logan County Fair Grounds S.  $4^{\circ}-35'$  W. 170.0 feet to an iron pin/with Johnson's north line N.  $86^{\circ}-03'$  W. 150.0 feet to the place of beginning containing 0.58 acres.

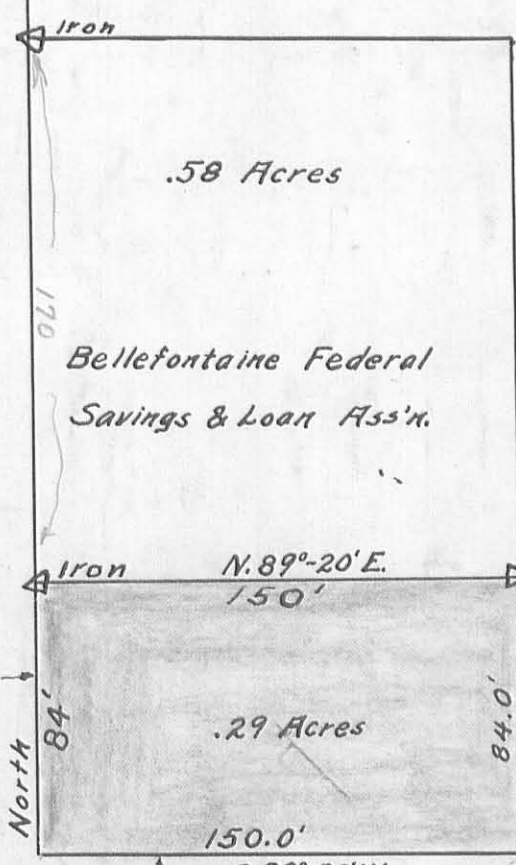
SURVEY FOR BELLEFONTAINE FEDERAL SAVINGS AND LOAN ASSOCIATION

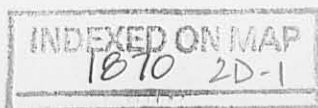

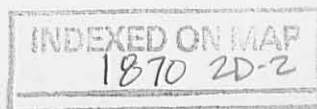
