### BRAGG 0.477 ACRE

Being all of the Roy L. Bragg and Patsy E. Bragg original 0.14 acre and 0.34 acre tracts as deeded and described in Official Record 304, Page 013, Tracts II and III of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 5/8 inch iron rod found at the intersection of the center-lines of Colton Avenue (36 feet wide) and Ludlow Road.

THENCE, with the center-line of Ludlow Road (60 feet wide), S 19°-35'-18" E, a distance of 101.68 feet to a point.

THENCE, S 70°-24'-42" W, a distance of 30.00 feet to a 5/8 inch iron rod found on the west right-of-way of Ludlow Road at the TRUE POINT OF BEGINNING.

THENCE, with the west right-of-way line of Ludlow Road, S 19°-35'-18" E, a distance of 107.36 feet to a 3/4 inch iron pipe found.

THENCE, with the north line of the Glenn F. Irwin 5.00 acre tract (O.R. 59, Pg. 638 Tract 1), S 88°-34'-43" W, a distance of 223.86 feet to a 3/4 inch iron pipe found.

THENCE, with the east line of Lot 3742 of Shields Allotment (Plat Cabinet A, Slide 299), N  $1^{\circ}$ -53'-05" E, a distance of 101.79 feet to a 5/8 inch iron rod found.

THENCE, with the south line of the Dorothy M. Davie 0.35 acre tract (Vol. 373, Pg. 196), N 88°-27'-30" E, a distance of 184.51 feet to the place of beginning.

Containing 0.477 acre.

### BRAGG 2 FEET WIDE BUILDING EASEMENT

Being a 2 feet wide building easement on the Glenn F. Irwin 5.0 acre tract as deeded and described in Official Record 59, Page 638 Tract 1 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 5/8 inch iron rod found at the intersection of the center-lines of Colton Avenue (36 feet wide) and Ludlow Road.

THENCE, with the center-line of Ludlow Road (60 feet wide), S 19°-35'-18" E, a distance of 209.04 feet to a point.

THENCE, S 70°-24'-42" W, a distance of 30.00 feet to a 3/4 inch iron pipe found on the west right-of-way of Ludlow Road.

THENCE, with the south line of the Roy L. Bragg original 0.34 acre tract (O.R. 304, Pg. 013 Tract III), S 88°-34'-43" W, a distance of 56.0 feet to a point at the place of beginning.

THENCE, with the north line of a 2 feet wide easement, S 88°-34'-43" W, a distance of 34.0 feet to a point at the terminus of this easement.

The basis for bearings is the center-line of Colton Avenue being N 90°-00′-00″ E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on October 13, 2000.


