

Organ Corporation Line Extension Description

Being situated in Lake Township, Logan County, Ohio; and being a part of V. M. S. 4478.

Beginning at an iron in the center of Eastern Avenue at the eastern extremity of the present Corporation Line, said iron is the southwest corner of Charles A. Davis' 0.50 acre tract. (The following five courses are along the present corporation line). Thence with the west line of Charles A. Davis' 0.50 acre tract N 5°-32' E 224.4 feet to a corner post; thence with the north side of said Davis tract S 83°-46' E 93.3 feet to a corner post; thence with the west side of J. L. Morris' 0.43 acre tract N 5°-30' E 86.5 feet to an iron in the southwest corner of Bellefontaine City Lot No. 3888; thence with the south side of Organ's Allotment S 84°-40' E 301.0 feet to an iron; thence with the east side of Organ's Allotment N 5°-35' E 902.1 feet to the center of County Highway No. 245, passing through an iron at 884.6 feet; thence with the center of County Highway No. 245 S 84°-26' E 285.8 feet to an iron in the northeast corner of Organ's 10.05 acre tract, thence with the east line of Organ's 10.05 acre tract S 5°-40' W 1168.3 feet to a corner post at the northeast corner of Everett L. Richard's 0.60 acre tract, thence N 84°-20' W 120.0 feet to an iron at the northwest corner of the Richard 0.60 acre tract; thence with the west line of the said Richard 0.60 acre tract S 5°-40' W 201.2 feet to the center of County Highway No. 10 (Eastern Avenue), passing through an iron at 170.0 feet; thence with the center of County Highway No. 10 N 68°-21' W 365.3 feet; thence continuing with County Highway No. 10 N 69°-31' W 214.6 feet to the place of beginning.

Containing a 0.50 acre tract of Charles A. Davis etux; a 0.50 acre tract, 0.43 acre tract, and a 0.09 acre tract of J. L. Morris; and a 5.72 acre tract and 4.33 acre tract of Cecil O. Organ etux; making a total of 11.57 acres more or less.
