
Thence S. $47^{\circ} 31'$ E. 7.00 feet to a point in the southwesterly line of Lot No. 3537;



Thence with the westerly line of said Lot S. $42^{\circ} 29' 00''$ W. 60.00 feet to the point of beginning for this description.


Thence S. $38^{\circ} 28' 45''$ W. 40.10 feet to a point.


