ORDINANCE NO. ___17-65

AN ORDINANCE VACATING THAT CERTAIN ALLEY BETWEEN LOTS 416 AND 417 AND THAT CERTAIN UNSUED 10 FOOT RIGHT OF WAY IN THE CITY OF BELLEFONTAINE, OHIO, AND FURTHER CHANGING THE ZONING CLASSIFICATION OF SAID LOTS 416 AND 417 FROM M-1 AND R-2, RESPECTIVELY, TO B-1 AND DECLARING AN EMERGENCY IN THE CITY OF BELLEFONTAINE, OHIO.

WHEREAS, a petition by Lutheran Community Services, Inc. ("LCS") owning lots in the immediate vicinity of the hereinafter described alley and right of way was duly presented to Council praying that said alley and right of way, or portion thereof, be vacated; and

WHEREAS, notice of said proposed alley and right of way vacation has been given according to law; and

WHEREAS, this Council, upon hearing in accordance with Ohio Revised Code Section 723.04, is satisfied that there is good cause for such vacation; that such vacation will not be detrimental to the general interest of the City; and, therefore, ought to be made;

WHEREAS, the City Planning Commission did after conducting public hearings thereon, make certain recommendations in writing to City Council that the zoning classification for the lands hereinafter described in the City of Bellefontaine, Ohio, be changed from M-1 and R-2, Light Manufacturing District and One and Two Family Residence District, respectively, to B-1, Neighborhood Business District; and

WHEREAS, Council did after proper notice, conduct a public hearing on the question of the change of zoning classification for such lands;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Bellefontaine, Ohio:

SECTION I: That a certain 16.5 foot wide by 146.85 foot long east-west alley between Lots 416 and Lots 417 in the City of Bellefontaine, Ohio, is hereby vacated, subject to the City of Bellefontaine retaining and reserving an easement for municipal utility purposes.

SECTION II: That the eastern 10 foot portion of the unused Troy Road right of way from Sandusky Ave. to Railroad Street in the City of Bellefontaine, Ohio, is hereby vacated, subject to the City of Bellefontaine retaining and reserving an easement for municipal utility purposes.

SECTION III: That the plat accompanying said petition be referred to the Clerk of this Council for filing with the Logan County Auditor and Recorder as provided by Ohio Revised Code Section 711.39 with any accompanying fee.

SECTION IV: That Council hereby determines that in the interest of promoting the public health, safety, convenience, comfort, prosperity and general welfare of the City of Bellefontaine, that the zoning classification of City Lots 416 and 417 located on the north side of the 800 block of West Sandusky Avenue adjacent to and immediately east of Troy Road, should be changed from M-1 and R-2, Light Manufacturing District and One and Two Family

Residence District, respectively, to B-1, Neighborhood Business District as recommended by the City Planning Commission and that the said real estate as hereinbefore described as said City Lots 416 and 417 in the City of Bellefontaine, Lake Township, Logan County, Ohio shall hereafter be zoned with the zoning classification of B-1, Neighborhood Business District.

SECTION V: That the official zoning map of the City of Bellefontaine be, and the same hereby is, amended to reflect the establishment of the zoning classification for said lands as herein set forth.

SECTION VI: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of said City, provide for its continuous uninterrupted services, and to allow for said zoning change and vacation of said alley and right of way at the earliest possible time; and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.





AN ORDINANCE VACATING THAT CERTAIN PUBLIC NORTH-SOUTH ALLEY BETWEEN LOT 418 ON THE EAST AND 417 ON THE WEST, IN THE CITY OF BELLEFONTAINE, LAKE TOWNSHIP, LOGAN COUNTY, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, a petition by Lutheran Community Services, owning lots in the immediate vicinity of the hereinafter described alley was duly presented to Planning Commission and Council praying that the hereinafter described alley be vacated; and

WHEREAS, waivers and consents to the proposed alley vacation have been filed by all abutting lot owners and notice of the intention of this Council to vacate said alley is not required pursuant to Ohio Revised Code Section 723,06; and

WHEREAS, the Planning Commission of the City of Bellefontaine has recommended that Council grant said petition; and

WHEREAS, this Council is satisfied that there is good cause for such vacation; that such vacation will not be detrimental to the general interest of the City; and, therefore, ought to be made.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Bellefontaine, Ohio:

SECTION I: That 16.5 foot wide and approximately 215 foot long North-South public alley, as more particularly outlined on Exhibit A attached hereto and incorporated herein, lying between City Lot 418 on the East and City Lot 417 on the West, in the City of Bellefontaine, be, and the same hereby are, vacated; reserving, however, unto the City of Bellefontaine easement rights for any and all municipal purposes. Parcels # 17-091-11-15-007-000 (Lot 418) and Parcels # 17-091-11-15-006-000 (Lot 417).




