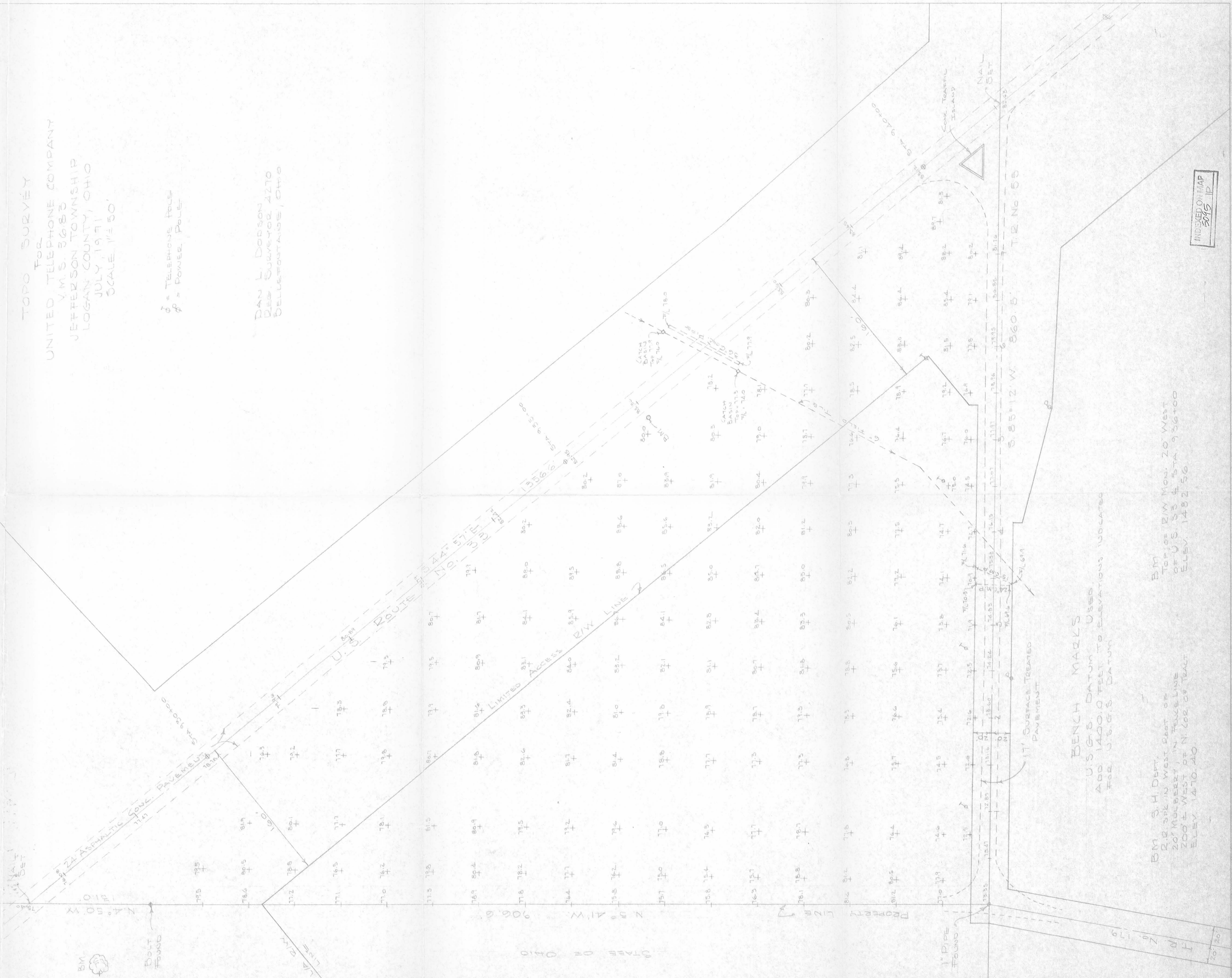

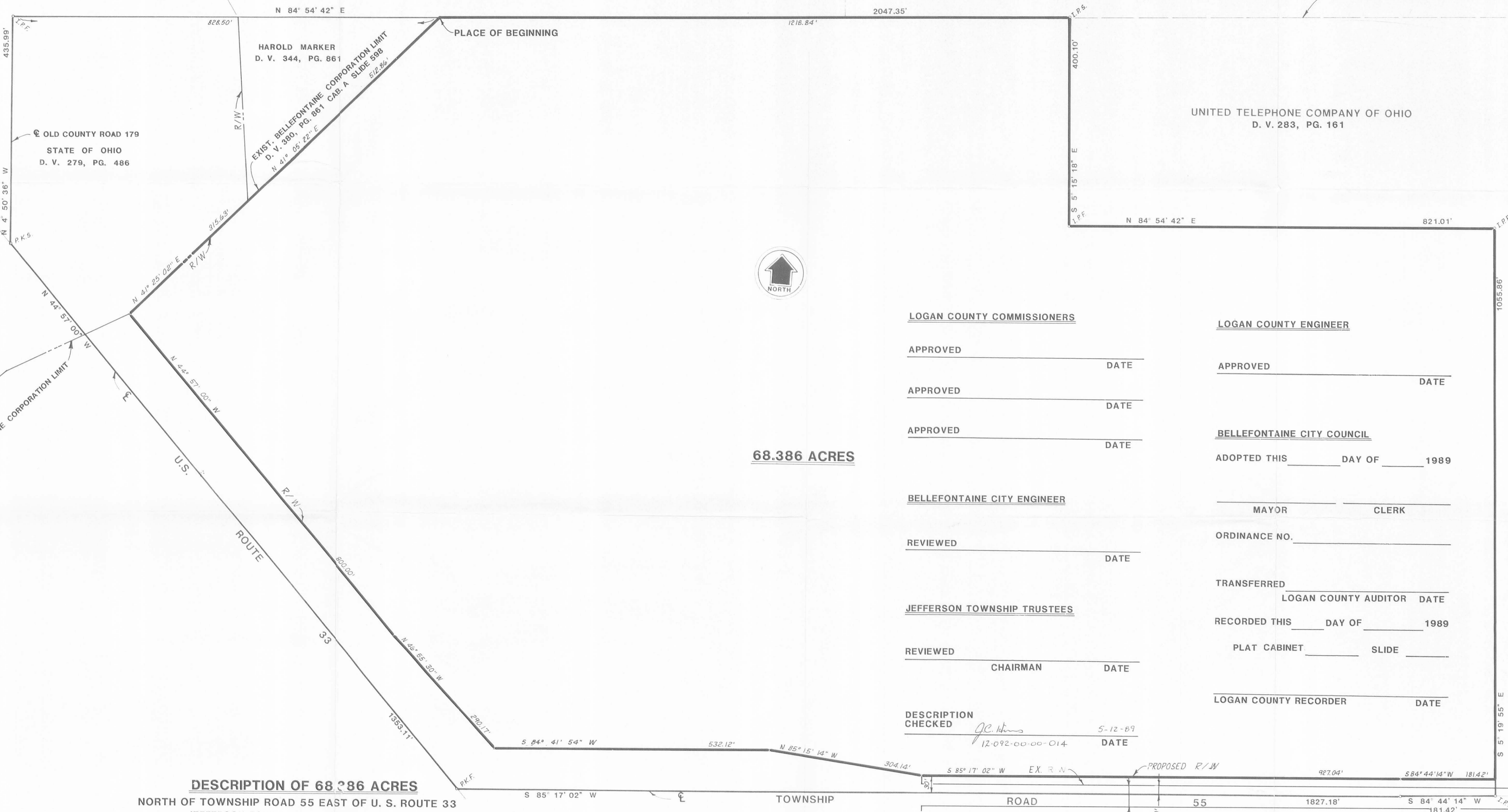

DESCRIPTION OF 68.386 ACRES

NORTH OF TOWNSHIP ROAD 55 EAST OF U. S. ROUTE 33
JEFFERSON TOWNSHIP, LOGAN COUNTY, OHIO

Situated in the State of Ohio, County of Logan, Township of Jefferson, being located in Virginia Military Survey Number 3683, being 68.386 acres of that 79.74 acre tract of land (79.663 acres by survey) as described in a deed to Harold Marker, of record in Deed Volume 344, Page 861, Recorder's Office, Logan County, Ohio, said 68.386 acres being more particularly described as follows:

Beginning at a point in the northerly line of said 79.74 acre tract located North 84° 54' 42" East, a distance of 828.50 feet from the northwesterly corner of same (in the centerline of old county Road 179) and at an angle point in the existing Bellefontaine Corporation Limit;

Thence North 84° 54' 42" East, along said northerly line, the existing Corporation Limit and the southerly line of the Ohio High Point Vocational Technical School property, a distance of 1,218.84 feet to a northeasterly corner of said 79.74 acre tract;

Thence South 5° 15' 18" East, along a westerly line of United Telephone Company property, a distance of 400.10 feet to a point;

Thence North 84° 54' 42" East, along a southerly line of said United Telephone Company property, a distance of 821.01 feet to a northeasterly corner of said 79.74 acre tract;

Thence South 5° 19' 55" East, along a westerly line of said United Telephone Company property, a distance of 1,055.86 feet to a point in the northerly right-of-way line of County Road 55;

Thence along said northerly right-of-way line, the following four courses and distances:

1. South 84° 44' 14" West, a distance of 181.42 feet to a point;
2. South 85° 17' 02" West, a distance of 927.04 feet to a point;
3. North 85° 15' 14" West, a distance of 304.14 feet to a point;
4. South 84° 41' 54" West, a distance of 532.12 feet to a point at the intersection of the easterly right-of-way line of U.S. Route 33;

Thence along said easterly right-of-way line, the following two courses and distances:

1. North 46° 55' 30" West, a distance of 290.17 feet to a point;
2. North 44° 57' 00" West, a distance of 800.00 feet to a point in the existing Bellefontaine Corporation Limit;

Thence North 41° 25' 02" East, along said Corporation Limit and along the U.S. Route 33 right-of-way line (for a proposed ramp) a distance of 315.63 feet to an angle point in said right-of-way line;

Thence, continuing North 41° 25' 02" East, along said Corporation Limit (through said 79.74 acre tract), a distance of 512.86 feet to the place of beginning and containing 68.386 acres of land.

Bearings herein are based on a bearing of North 44° 57' 00" West for the centerline of U.S. Route 33.

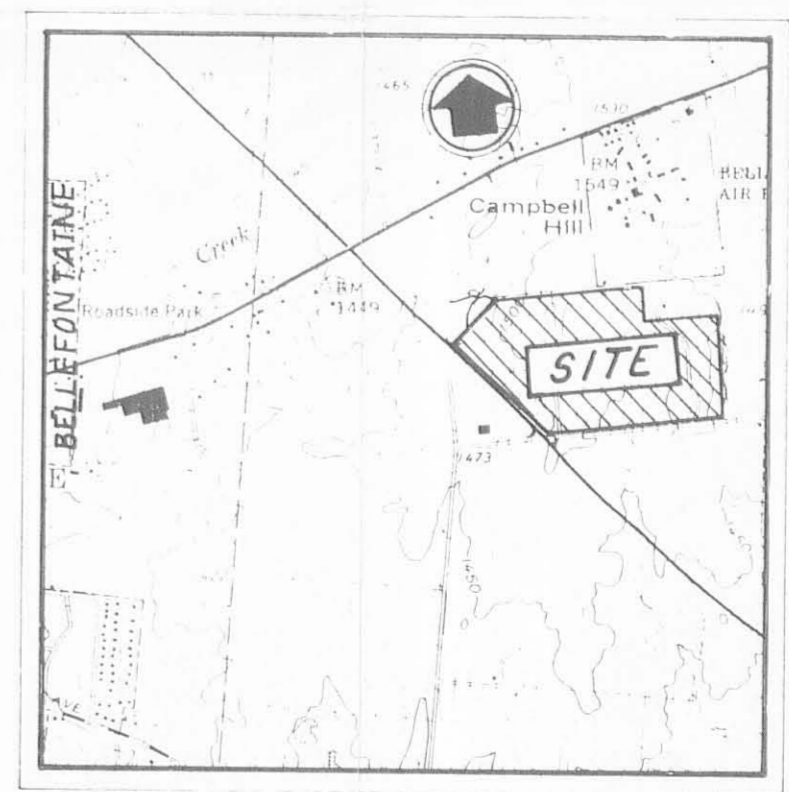

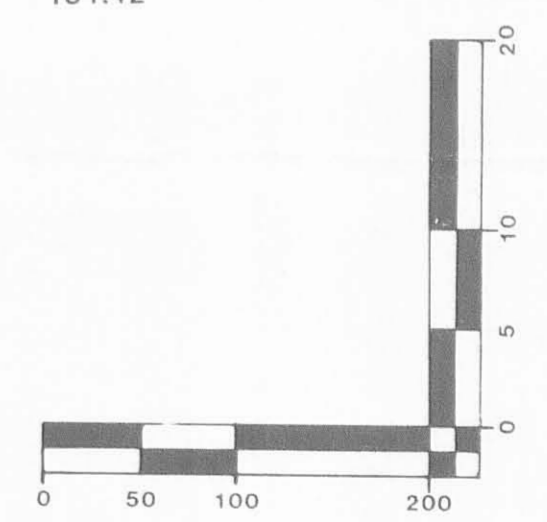

Lying in Virginia Military Survey 3683, Jefferson Township, City of Bellefontaine, Logan County, Ohio.

Being all of the remainder of the Harold Marker original 79.74 acre tract as deeded and described in Volume 344, Page 861 of the Logan County Records of Deed and being more particularly described as follows:

Beginning at a railroad spike found on the south line of Virginia Military Survey 3863, the City of Bellefontaine Corporation Line and the intersection of the center-lines of Township Road 55 and Sloan Boulevard.

THENCE, with the south line of Virginia Military Survey 3863, the City of Bellefontaine Corporation Line and the center-line of Township Road 55, (variable width), S 85°-17'-38" W, a distance of 65.00 feet to a MAG nail set at the TRUE POINT OF BEGINNING.

THENCE, with the south line of Virginia Military Survey 3863, the City of Bellefontaine Corporation Line and the center-line of Township Road 55, S 85°-17'-38" W, a distance of 706.67 feet to a MAG nail found.

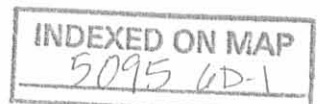

With a curve to the right having a central angle of $40^{\circ}-15'-30''$, a radius of 350.00 feet, an arc length of 245.92 feet and a chord bearing $S\ 24^{\circ}-50'-07''\ E$, a distance of 240.90 feet to a 5/8 inch iron rod found.

$S\ 4^{\circ}-42'-22''\ E$, a distance of 306.67 feet to a 5/8 inch iron rod set.

With a curve to the right having a central angle of $90^{\circ}-00'-00''$, a radius of 25.00 feet, an arc length of 39.27 feet and a chord bearing $S\ 40^{\circ}-17'-38''\ W$, a distance of 35.36 feet to a 5/8 inch iron rod set.

THENCE, $S\ 4^{\circ}-42'-22''\ E$, a distance of 30.00 feet to the point of beginning.

Containing 55.412 acres, of which 4.843 acres are within the highway right-of-way.

The basis for bearings is the center-line of the westbound lanes of U.S. Route 33, being $N\ 44^{\circ}-57'-00''\ W$, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on December 21, 1999.

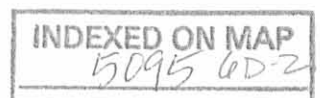

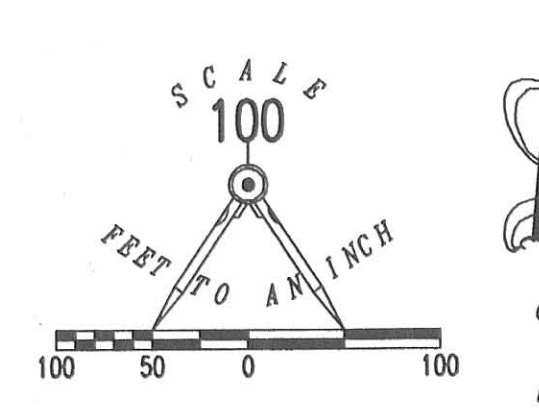

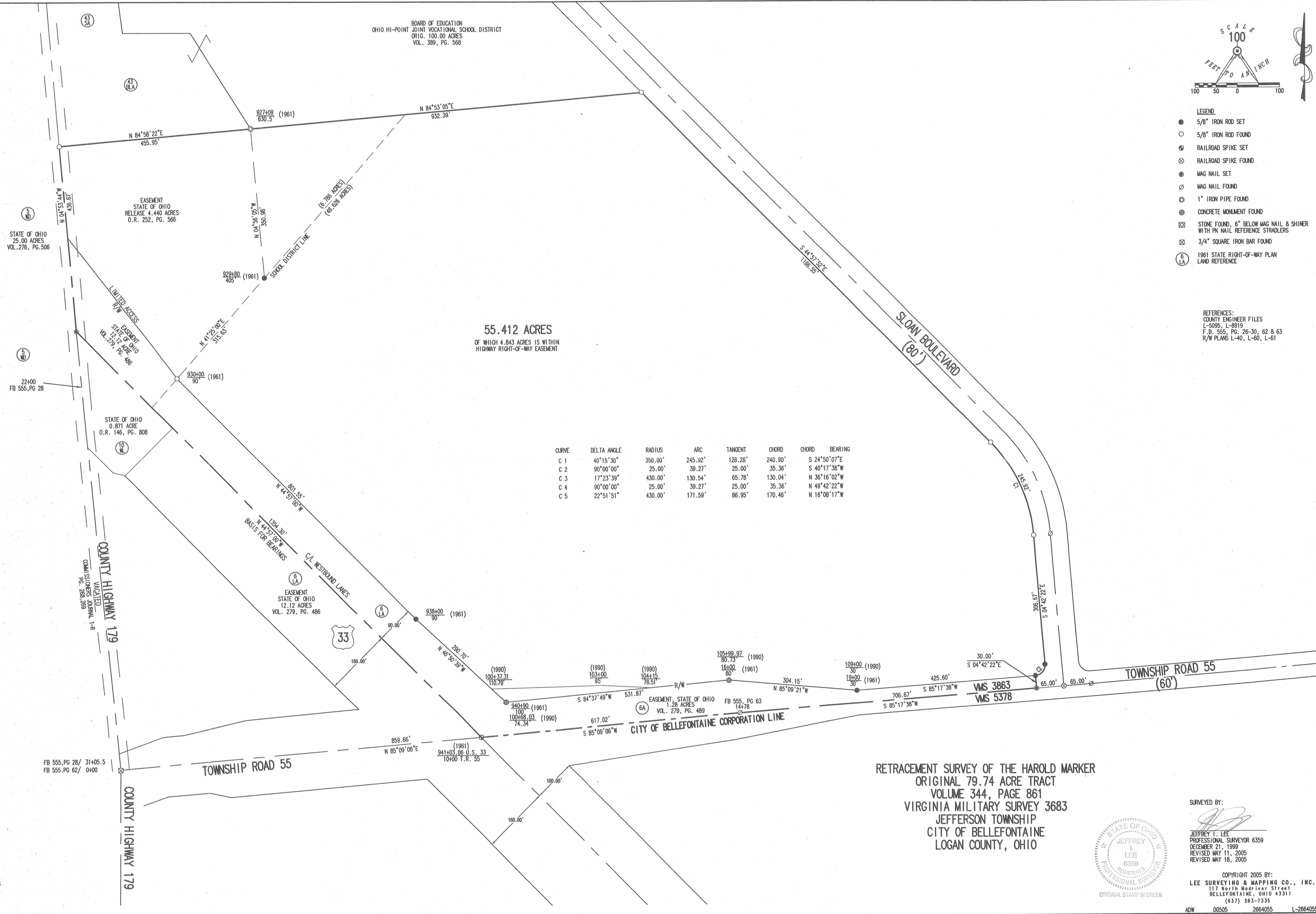


PLAT 31005 R/W 06

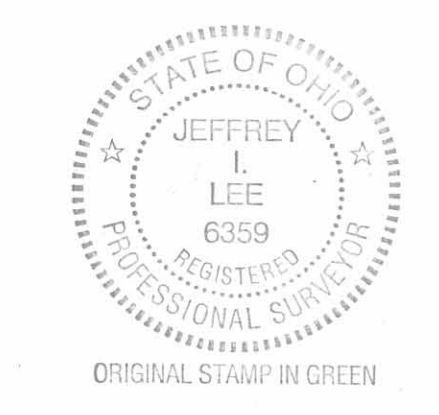
