Beginning at an iron bar in the south line of Carfield Avenue (formerly Lina Street) at the northwest corner to Jack H. Pepregla's present 0.10 Acre tract as described in Deed Volume 250 Page 522, said iron bar being N. 59° 30' W. 167.63 feet from the northeast corner to a tract of land conveyed by Issae S. Gardner to Joshua M. Dickinson by Deed Volume 60 Page 603 (12-20-1830), this being a reference deed to the current tract of land belonging to Paul T. Chiles, Jr.;

Thence continuing with the south line of Garfield Avenue, N. 59° 30' W. 40.00 feet to an iron bar in the cast line of a present 12.00 feet Alley or Right of Way, said iron bar being S. 59° 30' E. 12.00 feet from an iron pipe at the northeast corner to Doris A. Myers's present 0.12 Acre tract as being Tract No. Four in Deed Volume 299 Page 543 (11-25-1964):

Thence with the east line of said Alley or Right of Way, S. 28° 15' W. 119.06 feet to a point in the north line of a 12.00 feet Alley or Right of Way along the north line of the Right of Way of the C. S. & C. RR.;

Thence with the north line of said 12.00 foot Alley or Right of Way, S. 52° 44' E. 40.47 feet to a point in the west line of Jack H. Repregle's present tract;

Thence with the west line of Reprogle's tract, N. 28° 15' E. 123.84 feet to the place of beginning, containing 4,854.30 square feet or C.111 Acres, more or less.

The above being the same premises as described as Tract No. Three in Deed Volume 299 Page 543 (11-25-1964), Laird L. Myers (dec'd) to Doris A. Myers.



WEST 0.167 ACRE

Lying in Section 35, Town 4, Range 14, City of Bellefontaine, Lake Township, Logan County, Ohio.

Being all of the Ruth West 0.12 acre tract as deeded and described in Official Record 476, Page 859, Tract III, of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a MAG nail set at the intersection of the southwest right-of-way of Garfield Avenue (60 feet wide) and the south right-of-way of Sandusky Avenue (70 feet wide).

THENCE, with the southwest right-of-way of Garfield Avenue, S 53°-20'-20" E, a distance of 210.13 feet to a 5/8 inch iron rod found at the TRUE POINT OF BEGINNING.

THENCE, with the southeast line of the Clara Brown 0.06 acre tract (Vol. 373, Pg. 942), N 34°-32'-59" E, a distance of 30.02 feet to a MAG nail set.

THENCE, with the center-line of Garfield Avenue, S 53°-20'-20" E, a distance of 45.30 feet to a MAG nail set.

THENCE, with the northwest line of a 12 feet wide alley, S 33°-56'-07" W, a distance of 160.86 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 30.03 feet.

THENCE, with the northeast line of the Leroy Jauret original 1.538 acre tract (O.R. 373, Pg. 117, Tract III), N 46°-05'-15" W, a distance of 47.63 feet to a 5/8 inch iron rod set.

THENCE, with the southeast line of the said 0.06 acre tract, N 34°-32'-59" E, a distance of 124.75 feet to the point of beginning.

Containing 0.167 acre, of which 0.031 acre is within the highway right-of-way.



THENCE, with the south right-of-way of Garfield Avenue, S 53°-20'-20" E, a distance of 342.43 feet to a 5/8 inch iron rod found at the TRUE POINT OF BEGINNING.

THENCE, with the south right-of-way of Garfield Avenue, S 53°-20'-20" E, a distance of 47.72 feet to a 1 inch iron pipe found.

THENCE, with the west line of the Ruth West 0.15 acre tract (O.R. 476, Pg. 859, Tract I), S 36°-39'-40" W, a distance of 134.89 feet to a 5/8 inch iron rod set.




