Thence North 88°00'00" West (assumed bearing) 241.00 feet, following the centerline of East Columbus Avenue, to a magnetic nail set at the southwest corner of James L. and Janet L. Inskeep's ½ acre tract described in Deed Volume 333, page 854, and the southeast corner of said Van Voorhis' 0.60 acre tract, said magnetic nail marking the **place of beginning**;

Thence North 88°00'00" West 63.00 feet, continuing with the centerline of said Avenue and following the south line of said Van Voorhis' 0.60 acre tract, to a magnetic nail set at the southeast corner of Joseph A. and Ruth A. Bowden's ¼ acre tract described in Official Record 4, page 568;

Thence **North 01°14'49" East 388.51 feet**, departing from the centerline of said Avenue and following the east line of said Bowden's ¼ acre tract and the west line of said Van Voorhis' 0.60 acre tract, passing at 30.00 feet a magnetic nail set, to an iron pin set at the southeast corner of Keith J. and Vicki A. Sink's 0.15 acre tract described in Official Record 404, page 518 and the southwest corner of Randall L. and Roxanne J. Sprouse's 0.50 acre tract described in Official Record 111, page 716;

Thence North 89°20'58" East 63.16 feet, following the south line of said Sprouse's 0.50 acre tract and the north line of said Van Voorhis' 0.60 acre tract, to a 5/8 inch iron pin found in the west line of said Inskeep's ½ acre tract;

Thence South 01°15'58" West 391.43 feet, following the east line of said Van Voorhis' 0.60 acre tract and the west line of said Inskeep's ½ acre tract, passing at 361.43 feet an iron pin set, to the place of beginning, containing 0.565 acre, more or less, and being subject to all valid easements and restrictions of record. Of the above described 0.565 acre tract, 0.043 acre is within the right of way of East Columbus Avenue.




