Beginning at an iron rod set at the point of intersection of the north line of Eastern Avenue with the east line of Hayes Street (30 feet north of the center-line of Eastern and 20 feet east of the center-line

THENCE, with the said east line of Hayes Street, N 0°-07' E, a distance of 142.57 feet to an iron rod set at a west corner of said 1.794 acres.

THENCE, along the south line of a 0.094 acre lot (Volume 372, Page 253), S 88°-55' E, a distance of 75.70 feet to an iron rod set at the southeast corner of said 0.094 acre lot.

THENCE, with the east line of said lot and the east line of a 0.137 acre lot (Volume 372, Page 899), N 0°-07' E, a distance of 138.00 feet to an iron rod set at the northeast corner of said 0.137 acre lot in the south line of a 0.185 acre lot (Volume 334, Page 949).

THENCE, with said south line, S 88°-55' E, a distance of 151.57 feet to a point in the center of a creek.

THENCE, in, along and by said creek, the following (3) three bearings and distances:

S 11°-31'-50" E, a distance of 121.49 feet.

S 38°-34'-50" W, a distance of 112.92 feet.

S 20°-20'-25" W, a distance of 116.01 feet to the north line of Eastern Avenue.

THENCE, with said north line, N 74°-16' W, a distance of 146.68 feet to the point of beginning. Containing 1.203 acres.

Beginning at the west side of a pipe post found at the southeast corner of said 1.931 acre tract and lying on the north lot line of Eastern Avenue, a distance along said north lot line of 289.89 feet from the east lot line of Hayes Street.

THENCE, with said north lot line, N 74°-16' W, a distance of 143.21 feet to a point in the center of the creek.

THENCE, by, along and in said creek, N 20°-25'-10" E, a distance of 116.01 feet to a point, setting an iron rod for reference at 20.0 feet due east.

THENCE, continuing by, along and in said creek, N 38°-34'-50" E, a distance of 112.92 feet to an iron rod set on the east bank.

THENCE, continuing by, along and in said creek, N 11°-31'-50" W, a distance of 121.49 feet to a point in said creek on the grantor's north property line.

THENCE, with said north property line, \$88°-55' E, a distance of 52.17 feet to the west edge of a 3" pipe post found at the northeast property corner. Passing an iron rod at 25.0 feet.

THENCE, with the grantor's east line, S 0°-09' W, a distance of 353.89 feet to the point of beginning. Containing 0.591 acre.


