LEGAL DESCRIPTION FOR INGRESS-EGRESS EASEMENT

Being situate in the State of Ohio, County of Logan, City of Bellefontaine, Township of Lake, and being a part of Virginia Military Survey 4990, being a triangular tract of ground out of the southwest corner of a 0.57 acre tract owned by Brian Potter as recorded in Official Record 135, Page 879 of the Logan County Records, and being more particularly described as follows;

Beginning for reference at a 1/2' diameter iron bar found at grade at the intersection of the north line of Columbus Avenue and the east line of North Haves Street;

thence with the east line of said North Hayes Street, N-4°30'00"-E (this course being the basis of bearings for the herein described easement per a survey by Daniel Gilbert Professional Surveyor, all other bearings are based upon angles observed and distances measured in the field), 465.80' (feet) to an iron bar set at the PRINCIPLE PLACE OF BEGINNING for the easement hereinafter described, said iron bar set also being at the southwest corner of a 0.57 acre tract owned by Brian Potter as recorded in Official Record 135, Page 879, passing for reference a 1/2' diameter iron bar found at grade at the southwest corner of a 0.51 acre tract owned by Suzette Wallace as recorded in Official Record 82, Page 427 of the Logan County Records;

thence continuing with the east line of said North Hayes Street and with the west line of said Potter's tract, N-4°30'00"-E, 12.00' (feet) to an iron bar set;

thence S-86°53'32"-E, 51.85' (feet) to an iron bar set at grade on the southerly line of said Potter's tract, also being on the northerly line of aforementioned Suzette Wallace's tract;

thence with the southerly line of said Potter's tract and the northerly line of said Wallace's tract, S-80°09'00"-W, 53.50' (feet) to the place of beginning;

Containing 0.007 acre (310.9848 sq. ft.) but being subject to the rights of all legal highways and all easements of record.


