The above described easement being part of Donald R. Davis' Pt. Lot 936 as described in O. R. Vol. 41 Page 142.

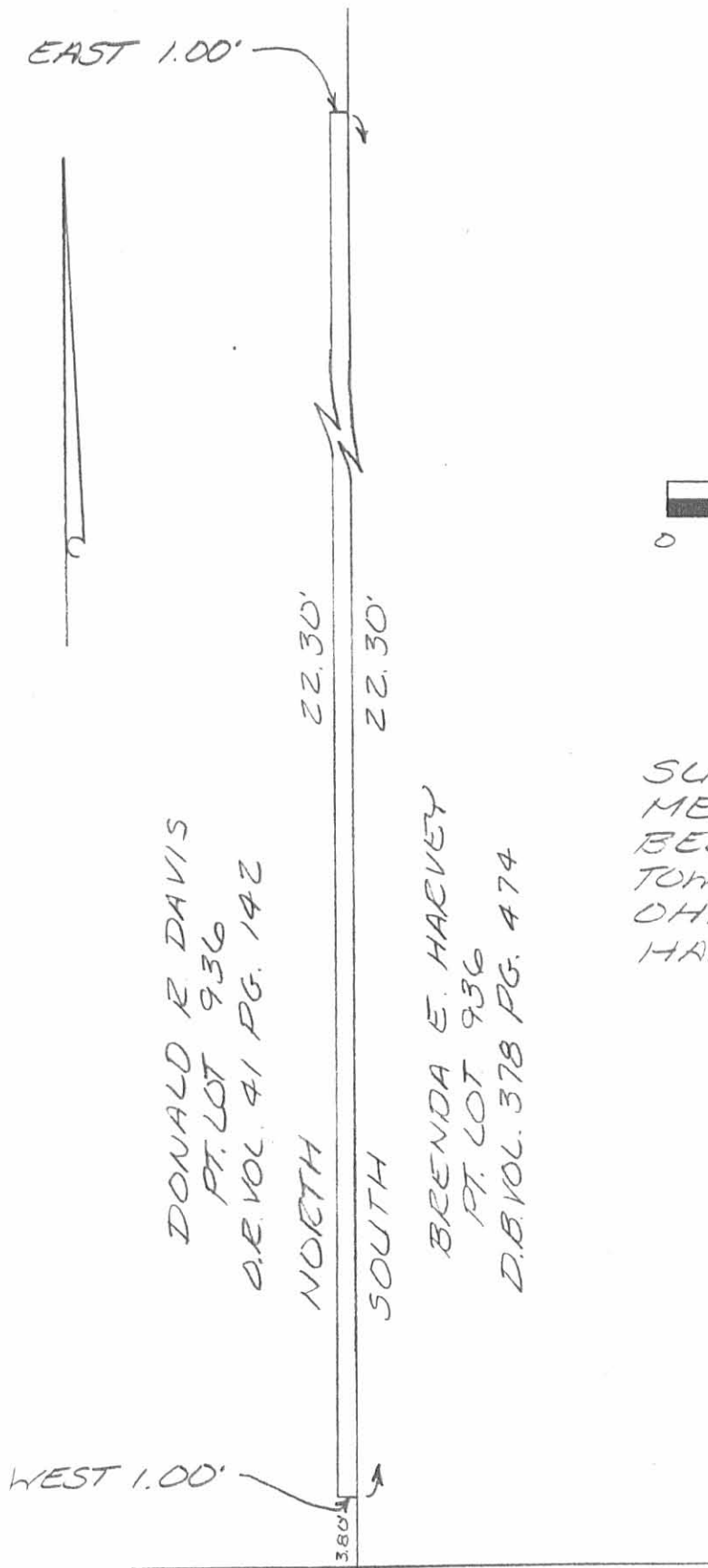

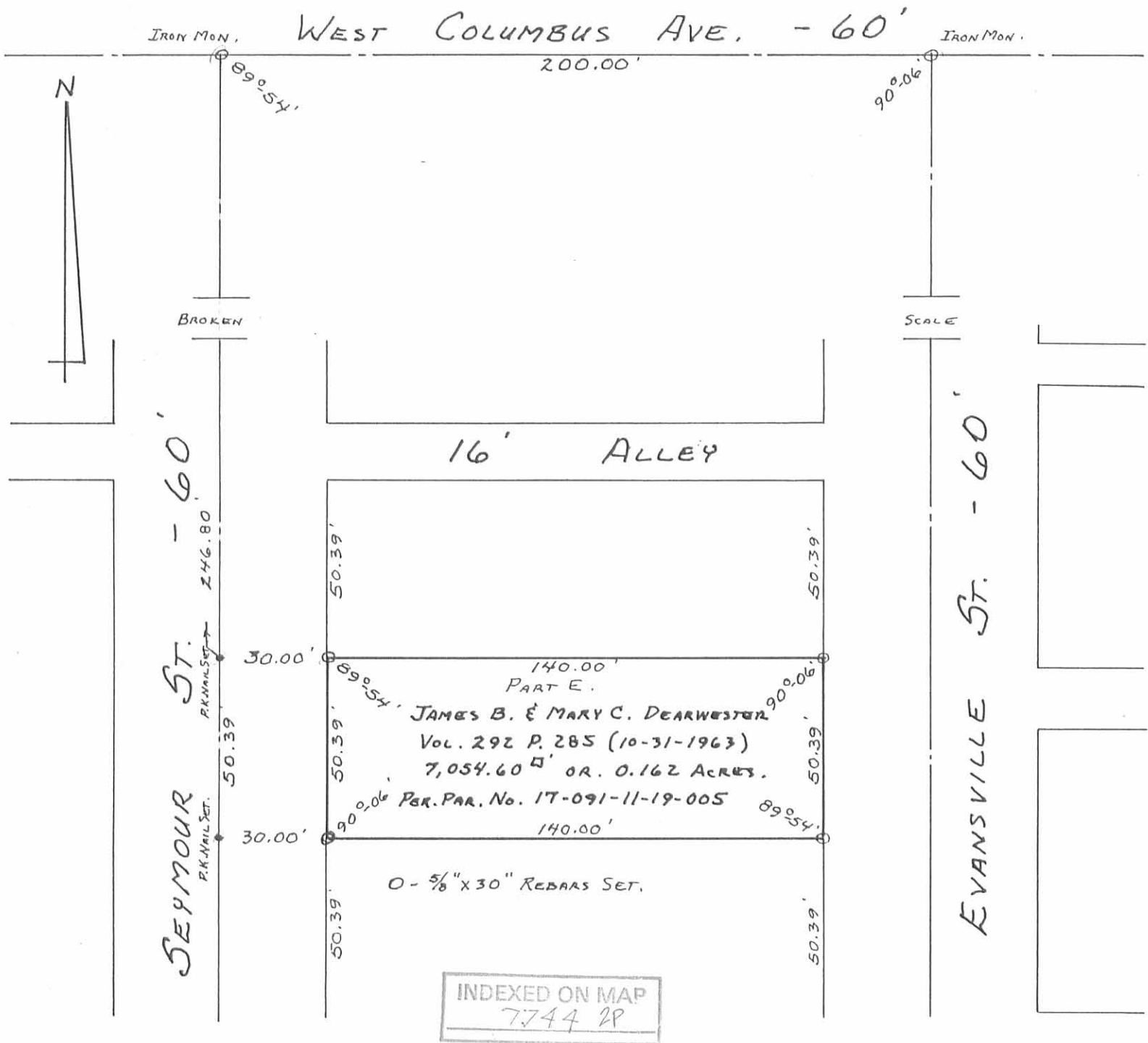

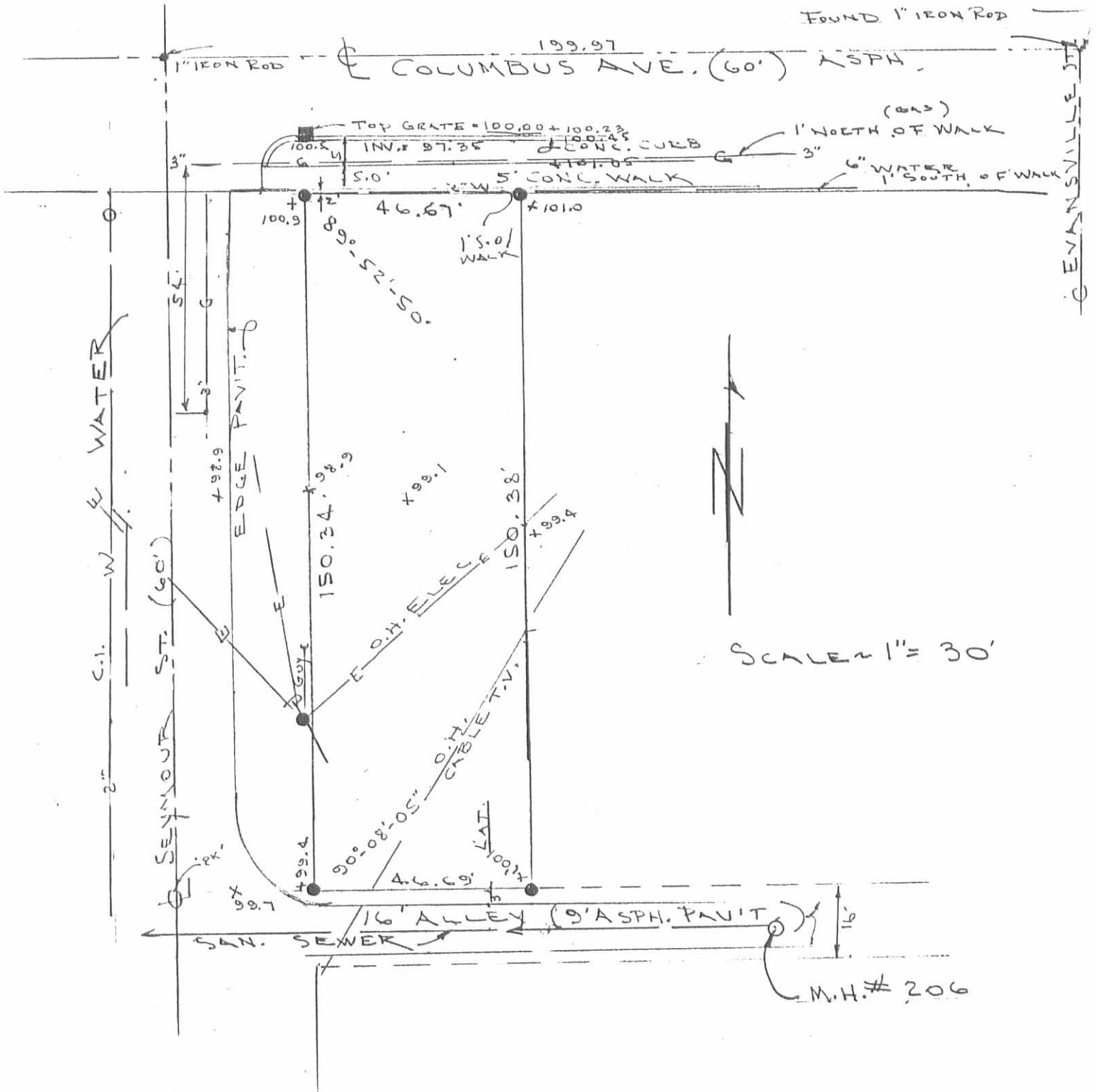
