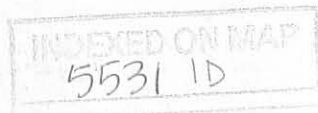

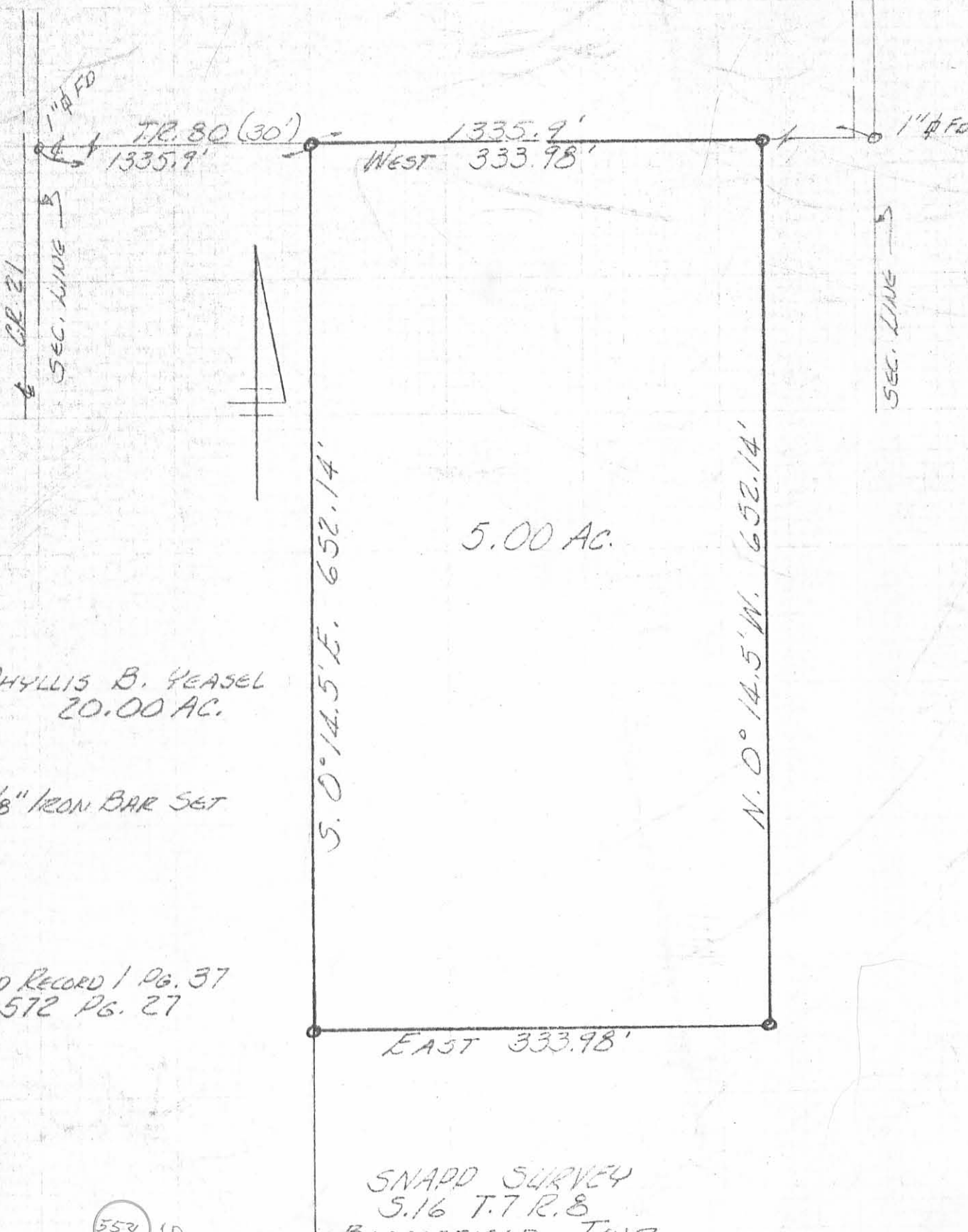
Containing 5.00 acres more or less.

SNAPP SURVEY

Lying in Section 16, T-7, R-8, Bloomfield Township, Logan County, Ohio and being 2.50 acres off the east side of that 5.0 acre tract deeded and described in Volume 354, Page 300 of the Logan County Records of Deeds and more particularly described as follows:

Beginning at an iron rod found at the northeast corner of said 5.0 acre tract on the quarter section line which lies within the road right-of-way of Township Road 80 and north of the present pavement and is east of the center of Section 16 a distance of 1670.88 feet.

THENCE, with the east-west quarter section line, West, a distance of 167.46 feet to an iron rod.

THENCE, S 0°-12' E, a distance of 652.14 feet to an iron rod set in the south line of the said 5.0 acres. Passing an iron spike set in the pavement at 15.00 feet.

THENCE, with the south line of the 5.0 acres, East, a distance of 167.46 feet to an iron rod found at the southeast corner.

THENCE, with the east line of the said 5.0 acres, N 0°-12' W, a distance of 652.14 feet to the point of beginning, passing an iron spike set in the pavement at 637.14 feet. Containing 2.50 acres.

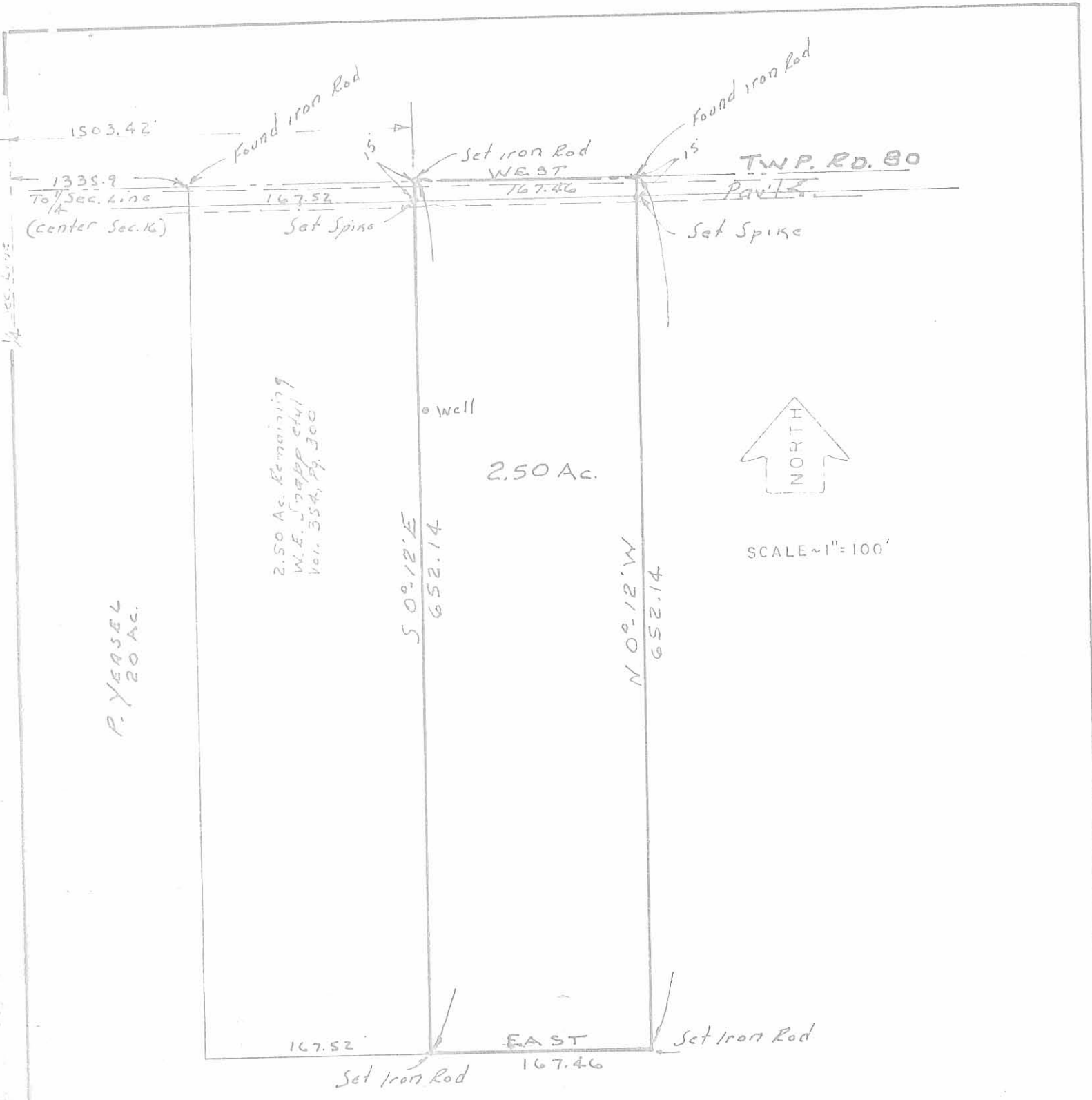
