thence S.0°-36.5'W. parallel with the North-South quarter section line of said Section No. 15, a distance of 1083.4 feet to a point in the north bank of the Muchinippi Creek, passing an iron bar at 45.4 feet in the right-of-way line of County Road No. 54 and passing over an iron bar at 1068.4 feet, 15 feet north of said Muchinippi Creek;

thence S.54°-01.5'E. along the north bank of the Muchinippi Creek a distance of 192.5 feet to a point in the North-South quarter section line of said Section No. 15; to a point in the north bank of Muchinippi Creek;

thence N.O°-36.5'E. along said North-South quarter section line and the west line of Ronald Bruce Williams 80 acre tract of land a distance of 1016.7 feet, passing over an iron bar at 15 feet, to the PLACE OF BEGINNING;

said tract of land containing 3.78 acres, more or less, of which 0.16 acre is dedicated for highway purposes.

The above tract of land being the same as described in Logan County Deed Record Volume 366, Page 130.



thence with the centerline of said County Road 54, S-40°47'00"-E, (this being the basis of bearings for the tract hereinafter described all other bearings are per angles observed and distances measured in the field) 2401.11' (feet) to a railroad spike with cross-notch set at grade at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described, passing for reference a 1/2" square iron bar found at grade on the west line of aforementioned Charles Williams 80 acre tract at 2032.90' (feet);

thence S-42°46'48"-W, 431.81' (feet) to an iron bar set, passing for reference an iron bar set at 30.11' (feet);

thence N-65°12'03"-W, 228.79' (feet) to an iron bar set;

thence N-52°49'48"-W, 167.41' (feet) to an iron bar set;

thence N-14°17'24"-E, 662.08' (feet) to the place of beginning, passing for reference an iron bar set on the southerly right-of-way line of said County Road 54 at 625.49' (feet);

Containing 6.333 acre, 0.479 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.
