PURTEE (1.794 ACRES)

Lying in Section 21, Town 7, Range 8, Bloomfield Township, Logan County, Ohio.

Being out of the Floyd C. Purtee lands as deeded and described in Volume 287, Page 320; Volume 294, Page 207, Tracts I, II, IV, and V; and Official Record 141, Page 363; all of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike set on the center-line of County Highway 21, N 2°-00'-00" E, a distance of 388.17 feet from a 5/8 inch iron rod found at the intersection of center-lines of County Highway 21 and County Highway 60.

THENCE, with the center-line of a 20 feet wide private street and the north line of the Floyd C. Purtee 0.49 acre tract (0.R. 33, Pg. 292), N 88°-00'-00" W, a distance of 166.65 feet to a 5/8 inch iron rod set.

THENCE, with the east line of the Harvey Wells 0.30 acre tract (O.R. 138, Pg. 603), N 2°-00'-00" E, a distance of 172.59 feet to a 5/8 inch iron rod set.

THENCE, with the north line of the said 0.30 acre tract, N 88°-00'-00" W, a distance of 73.59 feet to a 5/8 inch iron rod set.

THENCE, with the east line of the Jerry Knief original 13.0 acre tract (O.R. 53, Pg. 44), N 2°-00'-00" E, a distance of 205.59 feet to a 5/8 inch iron rod set.

THENCE, with the south line of the Floyd E. Scott 0.50 acre tract (Vol. 404, Pg. 858), S 88°-00'-00" E, a distance of 240.24 feet to a railroad spike set.

THENCE, with the center-line of County Highway 21, S 2°-00'-00" W, a distance of 378.18 feet to the point of beginning.

Containing 1.794 acres of which 0.260 acre is within the highway right-of-way.

The basis for bearings is based upon the center-line of County Highway 21 being S 2°-00'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on November 8, 1991.


