LEGAL DESCRIPTIONS FOR CLINEHENS' 2.542 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Bloomfield, and being a part of the Southwest Quarter of Section 30, Town 7-S, Range 8-E, and being more particularly described as follows:

Beginning for Reference at a Mag Nail set at the intersection of the centerline of Township Road 34 (40' right-of-way) and the South line of Section 30, Town 7-S, Range 8-E, also being the North line of Section 31, Town 7-S, Range 8-E, and being at centerline Station 16+63 per County Engineer's Field Book 596, Page 11;

Thence with the centerline of Township Road 34, N-6°35′32″-W, 242.89′(feet) to a Mag Nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

Thence N-85°50′26″-W, 243.05′(feet) to an iron bar set, passing for reference an iron bar set on the right-of-way line of Township Road 34 at 20.36′(feet);

Thence N-8°16'49"-W, 439.47'(feet) to an iron bar set;

Thence N-87°42′15″-E, 251.52′(feet) to a Mag Nail set on the centerline of aforementioned Township Road 34, passing for reference an iron bar set on the right-of-way line of Township Road 34 at 231.44′(feet);

Thence with the centerline of Township Road 34, S-7°19'35"-E, 71.68'(feet) to a ¾" diameter iron bar found at centerline Station 23+00;

Thence continuing with the centerline of Township Road 34, S-6°35′32″-E, 394.11′(feet) to the place of beginning.

Containing 2.542 acres, 0.213 acre of which is within the Road right-of-way, but being subject to the rights of all legal highways and all easements of record.

Being a part of a 60 acre tract conveyed to Gertrude Clinehens, Trustee, by deed recorded in Official Record 986, Page 176, Tract I, Parcel II, of the Logan County Records.

The foregoing description prepared by and in accordance with a survey by William D. Edwards, Professional Surveyor No. 7574, November 14, 2022. All iron bars set are 5/8"x30" iron re-bar with a yellow plastic cap stamped "EDWARDS PS 7574". Bearings are based on the centerline of Township Road 34 per an assumed bearing of N-6°35'32"-W.
