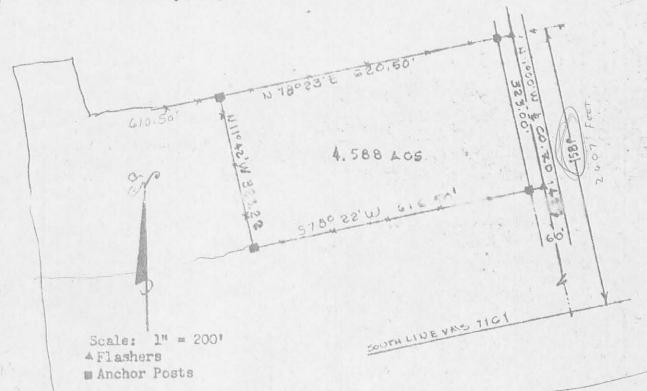
A survey of 4.588 acres of land in Virginia Military Survey No. 7161, Bokes Creek Township, Logan County, Ohio.



DESCRIPTION

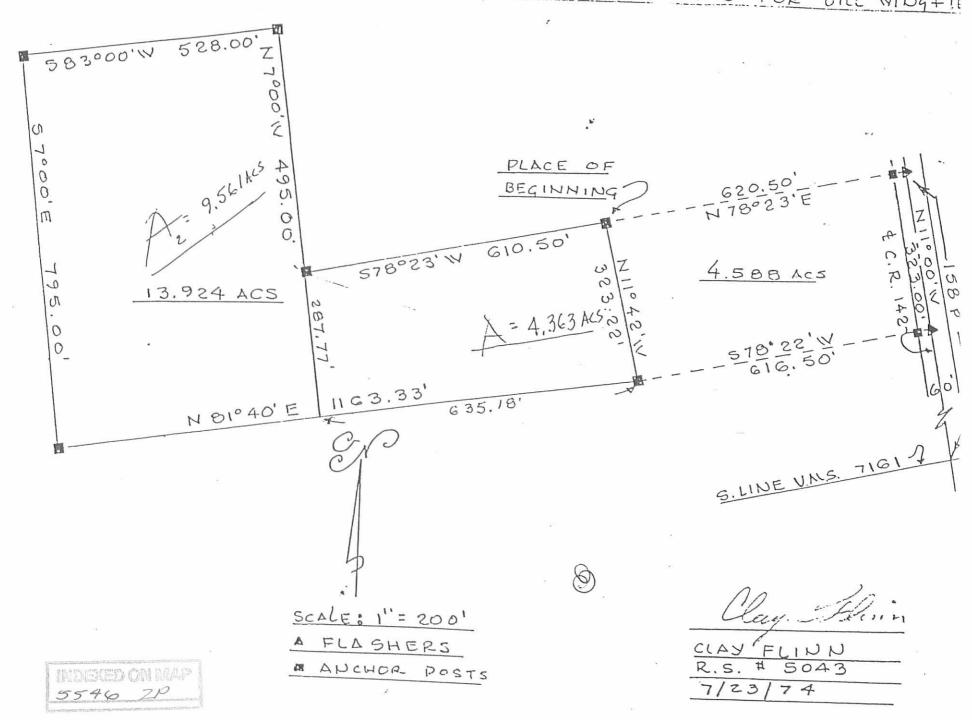
Being a part of Virginia Military Survey No. 7161, Bokes Creek Township, Logan County, Ohio and described as follows:

Beginning at a flasher in the centerline of County Road No. 142, where the north line of a 102.8 acre tract of land described in Logan County Deed Records, Volume 272, Page 575-576 intersects said centerline, said flasher also being 158 poles N 11 00 W from the intersection of said centerline with the south line of said V. M. S. No. 7161; thence S 11 00 E and along the centerline of said County Road No. 142 a distance of three hundred twenty three feet (323.00) to a flasher; thence S 78 22 W a distance of six hundred sixteen and five tenths feet (616.50) to an anchor post; thence N 11 2 W a distance of three hundred twenty three and twenty two hundredths feet (323.22) to an anchor post; in the north line of said 102.8 acre tract; thence N 78 23 E and along the north line of said 102.8 acre tract a distance of six hundred twenty and five tenths feet (620.50) to the place of beginning containing in all four and five hundred eighty eight thousandths acres (4.588 acs.) of land but subject to all legal highways.

SURVEY FOR DAVID AND GINA TIGHE 31.778 Acres December 5, 2011

The following described 31.778 acre tract is situated in the State of Ohio, County of Logan, Township of Bokescreek, V.M.S. 7161 and 10060, being part of Richard M. Tighe and Barbara E. Tighe, Trustees' 84.288 acre tract described in Official Record 1007, page 236, and said 31.778 acre tract being more particularly described as follows:

Beginning for reference at a 3/8 inch iron pin found at the intersection of the centerline of County Road 117 with the north terminus point of the centerline of County Road 142 (60 feet wide);

Thence South 09°45'00" East (assumed bearing) 3104.02 feet, following the centerline of County Road 142 to a magnetic nail set at a north corner of said 84.288 acre tract and at a southeast corner of Leonard Ray Payne and Ora Thomas Payne, Jr.'s 4.588 acre tract described in Official Record 753, page 815, said nail marking the place of beginning;

Thence South 09°45'00" East 772.27 feet, following the centerline of County Road 142 and crossing said 84.288 acre tract, to a magnetic nail set at the northeast corner of Barbara E. Tighe, Trustee's 20.7 acre Tract Four described in Official Record 1007, page 241;

Thence South 79°58'19" West 1053.33 feet, departing from the centerline of County Road 142, following a south line of said 84.288 acre tract and the north line of said 20.7 acre tract, passing at 31.00 feet a 12 inch concrete post found, to an iron pin set in the west line of V.M.S. 7161 and in the east line of V.M.S. 10060;

Thence South 09°59'23" East 338.00 feet, following an east line of said 84.288 acre tract and V.M.S. 10060 and the west line of said 20.7 acre tract and V.M.S. 7161, passing an iron pin set at 335.82 feet, to a stone found at the northeast corner of Barbara E. Tighe, Trustee's 40 acre Tract Two described in Official Record 1007, page 241;

Thence South 81°28'07" West 524.01 feet, entering V.M.S. 10060, following a south line of said 84.288 acre tract and the north line of said 40 acre tract, passing an iron pin set at 2.32 feet, to an iron pin set at the southeast corner of R & B Mouser Farms, Inc.'s original 165 acre tract described in Official Record 17, page 821;

Thence North 10°12'35" West 1082.97 feet, following a west line of said 84.288 acre tract and an east line of said original 165 acre tract, to an iron pin set at the southwest corner of Leonard Ray Payne's 13.924 acre tract described in Official Record 762, page 255;

Thence North 79°28'47" East 1584.63 feet, following a north line of said 84.288 acre tract, the south line of said 13.924 acre tract, departing from V.M.S. 10060 and entering V.M.S. 7161, also following the south line of said 4.588 acre tract and passing at 1554.63 feet an iron pin set, to the place of beginning, containing 31.778 acres, more or less, and being subject to all valid easements and restrictions of record.

Of the above described 31.778 acre tract, 18.593 acres are in V.M.S. 7161 and 13.185 acres are in V.M.S. 10060.

The above description was prepared from a field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor #6140, during the month of December 2011. Bearings indicated herein are based on an assumed meridian with all others based on angles turned. Iron pins set are 5/8 inch by 30 inch reinforcing jods with caps marked "CI APSADDLE RS #6140".

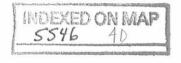
