Thence North 89°52'00" West 97.40 feet, following the centerline of State Route 47, the north line of V.M.S. 6251, the south line of V.M.S. 13068, and the north line of said 99.25 acre tract, to a magnetic nail set and marking the **place of beginning**;

Thence South 0°38'58" West 339.89 feet, departing from the centerline of State Route 47 and the south line of V.M.S. 13068, entering V.M.S. 6251 and said 99.25 acre tract, passing an iron pin set at 45.00 feet, to an iron pin set;

Thence South 42°27'47" West 44.94 feet to an iron pin set;

Thence South 1°56'48" West 223.51 feet to an iron pin set;

Thence South 51°04'29" West 174.59 feet to an iron pin set;

Thence South 17°35'12" West 124.93 feet to an iron pin set;

Thence North 20°58'02" West 58.52 feet to an iron pin set;

Thence North 3°43'21" East 772.61 feet, passing an iron pin set at 727.52 feet, to a magnetic nail set in the centerline of State Route 47, in the north line of V.M.S. 6251, in the south line of V.M.S. 13068, and in the north line of said 99.25 acre tract;

Thence South 89°52'00" East 186.14 feet, following the centerline of State Route 47, the north line of V.M.S. 6251, the south line of V.M.S. 13068, and the north line of said 99.25 acre tract, to the place of beginning, containing 2.983 acres, more or less, and subject to all valid easements and restrictions of record.

Of the above described 2.983 acre tract, 0.194 acre is within the road right-of-way of State Route 47.






