Thence **North 82°33'07"** East 1806.75 feet, departing from the centerline of Township Road 115 and the east line of V.M.S. 10837, entering V.M.S. 13593, following the north line of said 51.35 acre tract, the south line of said 35.0 acre tract, and the south line of Terrill Farms Incorporated's Parcel 2, originally 44.40 acres, described in Deed Volume 393, page 429, passing a railroad spike found at 2.47 feet and an iron pin set at 30.00 feet, to an iron pin set;

Thence North 7°54'01" East 119.76 feet, continuing along the north line of said 51.35 acre tract and following the east line of said 44.40 acre tract, to an iron pin set in the west line of June and R.L. Ford's 25.00 acre tract described in Official Record Volume 361, page 173;

Thence South 8°18'17" East 115.50 feet, following the east line of said 51.35 acre tract and the west line of said 25.00 acre tract, to an iron pin set at the northwest corner of said 21.73 acre tract;

Thence **North 82°55'15" East 784.74 feet**, following the north line of said 21.73 acre tract, the south line of said 25.00 acre tract, and the south line of Jeanne A. and Donald A. Young's Tract II, 25.75 acres, described in Deed Volume 389, page 472, passing a 5/8 inch iron pin found at 568.97 feet, to an iron pin set at the northwest corner of Darrell W. and Beverly A. Ramsey's Tract I, 49.48 acres, described in Deed Volume 395, page 263;

Thence South 7°59'15" East 1213.05 feet, departing from the south line of said 25.75 acre tract, following the east line of said 21.73 acre tract and the west line of said 49.48 acre tract, passing an iron pin set at 1183.05 feet, to a one inch iron pin found in



the centerline of County Road 12;

Thence South 82°45'00" West 2632.18 feet, following the centerline of County Road 12, the south line of said 21.73 acre tract and said 51.35 acre tract, passing a ³/₄ inch iron pin found at 564.79 feet, to the **place of beginning, containing 73.223 acres**, more or less, and subject to all valid easements and restrictions of record.

Of the above described 73.223 acre tract of land, 51.333 acres are all of said 51.35 acre tract, 21.890 acres are all of said 21.73 acre tract, and 2.625 acres are within the road right-of-way of County Road 12 and Township Road 115.


