Easement for Water Line for Village of De Graff From Kathleen Mann

Thence, with the west line of said Village of De Graff's tract N. -7°-09'-34"-E. a distance of 32.61 feet to a 5/8 inch diameter iron bar found on the north right of way line of Thatcher Street (County Highway Number 63), said point being the true point of beginning of this description;

Thence, with the north right of way line of Thatcher Street (County Highway Number 63), S. -59°-46'-00"-W. a distance of 126.37 feet to a 5/8 inch diameter iron bar found at the intersection of said right of way line and the east property line of Sandra J. and Randy E. Green's original 6.560 acre tract as recorded in Official Records Volume 478, Page 378:

Thence along the east line of said 6.560 acre tract, N. -21°-24'-44"-W. a distance of 10.12 feet to a point;

Thence N. -59°-46'-00"-E. a distance of 129.08 feet to a point in the west line of said 5.241 acre tract;

Thence with said west line of said 5.241 acre tract S. -7°-09'-34"-E. a distance of 10.87 feet to the true point of beginning.


The easement contains 0.029 acres, more or less.


