## LEGAL DESCRIPTION FOR DODDS' 0.110 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Village of DeGraff, Miami Township, and being a part of Fractional Section 7, Town 2, Range 14, and being more particularly described as follows;

Beginning for reference at a 1" square iron bolt found at the intersection of the South line of Pleasant Street (50' right-of-way) and the East line of Koke Street (60' right-of-way), also being at the Northwest corner of a 0.22 acre tract conveyed to Sharon K. Dodds by Deed recorded in Official Record 533, Page 640, Tract 1, of the Logan County Records;

thence with the East line of Koke Street, S-23°00'00"-E, 114.60' (feet) to an iron bar set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, said iron bar set also being at the Southwest corner of said Dodds' 0.22 acre tract;

thence N-67°56'01"-E, 119.99' (feet) to an iron bar set at the Southeast corner of said Dodds' 0.22 acre tract, also being on the West line of a 0.33 acre tract conveyed to Leah Belle Garvey, etal, by Deed recorded in Official Record 277, Page 567, of the Logan County Records;

thence with the West line of said Garvey's tract, S-23°05'01"-E, 40.00' (feet) to an iron bar set at the Northeast corner of a 0.25 acre tract conveyed to Charles Stevens by Deed recorded in Official Record 65, Page 252, of the Logan County Records;

thence with the North line of said Stevens' tract, S-67°56'00"-W, 120.05' (feet) to an iron bar set on the aforementioned East line of Koke Street;

thence with the East line of said Koke Street, N-23°00'00"0-W, 40.00' (feet) to the place of beginning.

Containing 0.110 acre but being subject to the rights of all legal highways and all easements of record.

Being a more accurate description of a 0.11 acre tract conveyed to Sharon K. Dodds by Deed recorded in Official Record 533, Page 640, Tract 2, of the Logan County Records.


