· Being situate in the State of Ohio, County of Logan, Village of DeGraff, Miami Township, Section 7, Town 2, Range 14, and being a part of Out Lot 3 of Gilcrist's Addition as recorded in Plat Cabinet A, Slide 81, of the Logan County Plat Records, and being more particularly described as follows:

Beginning for reference at a 5/8" diameter iron bar with "Lee" cap found at the Southeast corner of Out Lot 1 of said Gilcrist's Addition, also being at the Northeast corner of a 0.37 acre tract conveyed to Vernon W. Dressback by Deed recorded in Official Record 77, Page 291, Tract 1, and at the Northwest corner of a 1.175 acre tract conveyed to the Village of DeGraff, Logan County, Ohio, by Deed recorded in Official Record 313, Page 564, Tract 1, of the Logan County Records;

thence with the Easterly line of said Dressback's 0.37 acre tract and the Westerly line of said Village of DeGraff's 1.175 acre tract, S-19°49'02"-E, 55.09' (feet) to a 7/8" diameter iron bar found at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described, said iron bar found also being at the Northeast corner of a.0.08 acre tract also conveyed to Vernon W. Dressback by Deed recorded in Official Record 77, Page 291, Tract 2, of which the herein described parcel is a part of;

thence continuing with the Westerly line of Village of DeGraff's 1.175 acre tract, S-19°50'00"-E, 16.60' (feet) to a 7" diameter wood corner post found, passing for reference an iron bar set at 14.60' (feet);

thence S-21°13'41"-W, 40.74' (feet) to a 5/8" diameter iron bar found at the Northeasterly corner of a 0.587 acre tract conveyed to William L. Glasgow, etux., by Deed recorded in Official Record 350, Page 408, of the Logan County Records and being on the West line of aforementioned Dressback's 0.08 acre tract and also being at a Southeast corner of aforementioned Dressback's 0.37 acre tract;

thence N-16°15'54"-W, 50.22' (feet) to a iron bar set at the Northwest corner of said Dressback's 0.08 acre tract;

thence N-76°56'13"-E, 23.80' (feet) to the place of beginning.

Containing 0.019 acre, but being subject to the rights of all legal highways and all easements of record.

Being a part of a 0.08 acre tract conveyed to Vernon W. Dressback by Deed recorded in Official Record 77, Page 291, Tract 2, of the Logan County Records.


The herein described parcel is to be attached to mentioned Dressback's existing and adjoining 0.37 acre tract and is not to be used as a separate and independent parcel.

Thence with the west line of said 0.08 acre tract S.24°33'23"E. 185.79 feet to the place of beginning.


Containing 0.587 acre more or less of which 0.171 acre is in Outlot 2 and 0.416 acre is in Outlot 3 of Gilchrist Addition.
