SURVEY FOR PAUL A. CHAMBERLAIN

0.36 Acre

April 1, 1981

The following described tract of land is situated in the State of Ohio, County of Logan, Township of Perry, Village of East Liberty, V.M.S. # 4689, being Lot 4 and part of Lot 3 of the PLAT OF THE TOWN OF EAST LIBERTY as recorded March 14, 1834 in the office of the Logan County Recorder, being all of Paul A. Chamberlain's 29 poles(square poles) tract described in Deed Volume 370, Page 351 and all of Paul A. Chamberlain's 7720 square feet tract described in Deed Volume 201, Page 424, being more particularly described as follows:

Beginning at an iron pin set at the northeast corner of said Lot 4, being in the south line of a $16\frac{1}{2}$ feet wide alley and in the west line of Main Street(80 feet wide), said iron pin marking the principal place of beginning;

thence South 20000' East(assumed bearing) 81.90 feet, following the east line of said Lot 4 and said Lot 3 and west line of Main Street, to an iron pin set and being South 7003' West 3.65 feet from an iron pipe found;

thence South $70^{\circ}03^{\circ}$ West 192.00 feet, through said Lot 3, to an iron pin set in the west line of said Lot 3 and being in the east line of a $16\frac{1}{2}$ feet wide alley;

thence North 20°00' West 81.73 feet, following the east line of said alley and west line of said Lot 3 and Lot 4, to an iron pin set in the south line of a 16½ feet wide alley;

thence North 70°00° East 192.00 feet, following the south line of said 16½ feet wide alley and north line of said Lot 4, to the principal place of beginning, containing 0.36 acre, more or less, and subject to all valid easements or restrictions of record.
