Affiant further states that he did personally set the monuments on the field survey of these tracts on September 29, 1983, but that due to typographical error, the legal description contained incorrect calls. The monumentation on the corrected description and the prior description is the same. The corrected description being as follows with corrections underlined:

Beginning at an iron rod found on the center-line of Township Road 198, marking the northeast corner of said 2.94 acre tract and being a distance of 1200.55 feet southerly along said center-line from the center-line of County Highway 11.

THENCE, with the center-line of Township Road 198, S $5^{\circ}-30'$ W, a distance of 160.50 feet to an iron bar.

THENCE, N 84°-24′-30″ W, a distance of 400.00 feet to an iron rod set on the west line of said 2.94 acres.

THENCE, with said west line, \underline{N} $\underline{5^{\circ}-30'}$ \underline{E} , a distance of 160.50 feet to an iron pipe found marking the northwest corner of said 2.94 acre tract.

THENCE, with the north line of said 2.94 acre tract, \underline{S} $\underline{84^{\circ}-24'-30''}$ \underline{E} , a distance of 400.00 feet to the point of beginning.


