


## SURVEYOR'S NOTE

AFTER REVIEWING ADJACENT SURVEYS AND SURVEYS PERFORMED IN THE 1800'S, THE SOUTHWEST QUARTER, AS WELL AS THE ENTIRE SECTION, HAS AN EXCESS OF THE USUAL 160 AND 640 ACRES, RESPECTIVELY.
