

#### McINTIRE SURVEY

Thence N. 4° 33' 00" E. 381.69 feet to the place of beginning, passing a 5/8 inch iron bar set at 351.69 feet.


Containing 2.000 acres more or less of which 0.157 acre is in the right of way of County Highway 13.
