Stewart --- Cushman Survey (Tract # 2)

The following described land being in V.M.S. 3138 and being in Jefferson Township Logan County Ohio.

Beginning at a point where the center of Goose Creek (so called) intersects with the center of Mad River; thence with the center of Mad River N. 1 30 E. 352 feet; thence continuing with the center of Mad River N. 0 52 E. 500 feet; thence again with the center of Mad River N. 2 55 E. 351 feet; thence N. 46 24 W. 142 feet to an iron; thence N. 27 37 W. 382 feet to an iron; thence N. 20 10 M. 362 feet to an iron at the south side of a private lane; thence with the south side of said lane N. 68 0 W. 370 feet to an iron (the last described line crossing and old open ditch and also a new dredged channel) thence S. 3 57 E. 480 feet to an iron; thence S. 28. 48 E. 428 feet to an iron; thence S. 1 32 W. 1022 feet to the center of Goose Greek thence with the center of Goose creek S. 43 30 E. 329 feet to the place of beginning said tract containing 10.3 acres more or less and being the same tract as surveyed Sept. 1927 and being shown and recorded in Logan County Surveyor's field book # 419 page 43

SELL and CONVEY, to the said Mortimer Vanhining his heirs and assigns forever, the following Realestate, situate in the County of Logan in the State of Ohio, and in the Virginia Military SurveyNo.3138 in Jefferson Tp. a d bounded and described as follows, Viz:

Being all that part of a tract of land containing six (6) acres and three rods more or less conveyed to said Shoots by Jesse L.

Marmon on the third day of Sept. I86I lying east of the west bank of Madriver; said Vanhining to construct and keep in repair the fence on the west bank of Madriver between said Shoots on the west and the above described piece of land.

Also, a strip or parcel of land for a roadway being a part of the above described lot of land conveyed by Jesse L. Marmon to Benjamin Shoots and a part of the two hundred acre lot of land conveyed by R.S.Canby and wife to Benjamin and lying along the north line of said lands and being 20 ft. wide and extending from Mad River to the pike leading from Zanesfield to West Liberty a distance of IO4 poles. Said Vanhining to fence both sides of said road and he his heirs and assigns to keep in repair the fence on the south side of said road and a failure so to do to work a forfeiture to the right of said roadway.
