
LEVAN DESCRIPTION V. M. S. 3220-6449 JEFFERSON TOWNSHIP August 1, 1963

Commencing at an iron pipe at the intersection of centerlines of County Highway 55 and County Highway 182 as shown in Logan County Engineer's field book 607, page 44; thence with the centerline of said County Highway 182, S. 87°07' E. 551.1 feet to an iron bar, said bar being the beginning point of this description; thence N. 3°39' E. 250.0 feet to an iron bar; thence N. 87°07' W. 244.6 feet to an iron bar; thence N. 5°13' E. 475.6 to an iron bar in the south line of E. N. Stephen's 4.00 acre tract; thence with said Stephen's south line and the south line of Russell R. Ede's 32.50 acre tract, 1016.6 feet to a stone; thence continuing with said Ede's south line the following four courses, S. 22° W. 240.9 feet to a stone; thence S. 88° E. 998.2 feet; thence N. 32° E. 214.5 feet to a stone; thence S. 87%° E. 775.5 feet to a stone at the southeast corner of said tract and in the west line of Francis Ganson's 50.66 acre tract; thence with said Ganson's west line S. 93/4° E. 1044.5 feet to a stone in the north line of V. M. S. 6447; thence with said survey line N. 85°43' W. 389.4 feet to a stone at the northwest corner of said V. M. S. 6447; thence with the west line of said survey S. 4°32' W. 30.0 feet; thence N. 85°43' W. parallel to



and 300.0 feet north of the centerline of said County Highway 182, 1325 feet; thence N. 4°57' E. parallel to and 300.0 feet east of the centerline of said County Highway 182, 311.1 feet to an iron bar; thence N. 85°03' W. 300.0 feet to an iron bar in the center of said County Highway 182; thence with said centerline N. 4°57' E. 21.0 feet to an iron bar, said iron bar being Sta. 76+02; thence with said centerline N. 87°07' W. 763.8 feet to the place of beginning.
