Being out of that 207.38 acres deeded and described in Volume 379, lage 523 of the Logan County Records of Deeds and Lying south of and abutting the Blacklidge 4.32 acre tract (Volume 321, Page 930) and west of and abutting the Blacklidge 11.53 acre tract (Volume 321, Page 859) and being a triangle of land remaining on the north side of Township Road 182 after the new re-location of said road (Refer: Eng'r. Map X-182 of 1975 relocation and Field Book 607). Approved December 1979 and better described as follows:

Beginning at a corner stone found marking the northeast corner of grantor's said 207.38 acre on the west line of V.M.S. 6447.

THENCE, with said V.M.S. line, S 7°-45° W, a distance of 232.15 feet to an iron rod set at the northeast corner of a 20 foot wide lane. (0.41 acre-Volume 328, Page 706).

THENCE, across the north line of said lane, N 82°-15' W, a distance of 20.00 feet to an iron rod set at the northwest corner of said lane.

THENCE, with the west line of said lane, S 7°-45' W, a distance of 29.84 feet to an iron rod set on the center-line of the aforementioned new relocation at County Highway Station 51+26.13.

THENCE, with said new center-line, N 35°-36'-15" W, a distance of 167.13 feet to the point of curve of a 13° curve to the left a distance of 361.03 feet (Chord = N 59°-04'-15" W, 351.02 feet) to the point of tangency of said curve on the north line of grantor's said 207.38 acres and on the center-line of the old location of Township Road 182.

THENCE, with said center-line and property line, S 82°-32'-15" E, a distance of 457.43 feet to the point of beginning. Containing 0.956 acres.






