The above described 2.62 Acres being on the west side of Phyllis J. Masterson's present 4.82 Acre tract.

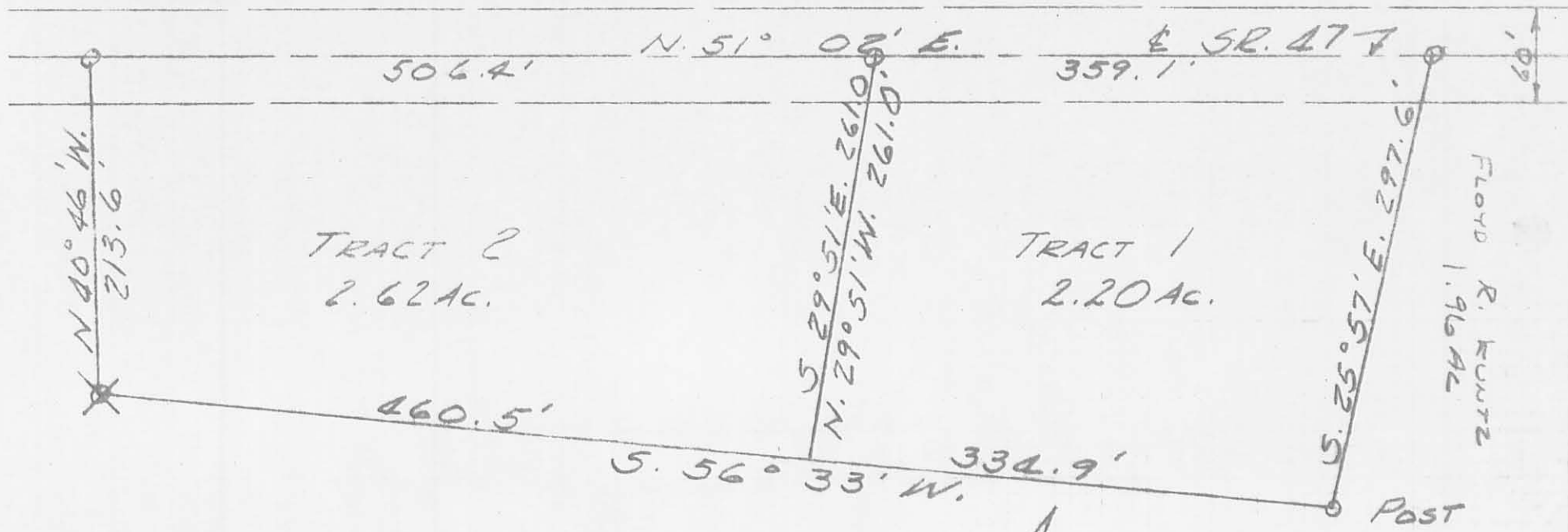
