JANANNE PROPERTIES 1.396 ACRES

Lying in Virginia Military Survey 4498, Jefferson Township, Logan County, Ohio.

Being out of the Jananne Properties original 102.489 acre tract as deeded and described in Official Record 120, Page 479, Tracts III, IV, and V of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike found at the intersection of the center-line of Township Road 181 and the line between Jefferson Township and Lake Township.

THENCE, with the center-line of Township Road 181 (40 feet wide), S 83°-53'-00" E, a distance of 438.88 feet to a railroad spike found at the TRUE POINT OF BEGINNING.

THENCE, with the lines of the William L. Myers 0.987 acre tract (O.R. 90, Pg. 438) the following two courses: N 5°-33'-02" E, a distance of 286.68 feet to a 5/8 inch iron rod found.

N 5°-33'-02" E, a distance of 286.68 feet to a 5/8 inch fron rod found. N 83°-53'-00" W, a distance of 150.00 feet to a 5/8 inch iron rod found.

THENCE, N 5°-33'-02" E, a distance of 290.41 feet to a 5/8 inch iron rod set.

THENCE, S 83°-53'-00" E, a distance of 179.40 feet to a 5/8 inch iron rod set.

THENCE, with the west line of the Glenna Lyon 58.96 acre tract (Vol. 337, Pg. 440), S 5° -27'-00" W, a distance of 577.11 feet to a stone found.

THENCE, with the center-line of Township Road 181, N 83°-53'-00" W, a distance of 30.41 feet to the point of beginning.

Containing 1.396 acres of which 0.014 acre is within the highway right-of-way.

The basis for bearings is based upon the center-line of Township Road 181 being N 83°-53'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on May 24, 1994.




