thence on C.R. 153 following the tangent of a  $4^{\circ}$ -30' curve to the right having a tangent length of 112.50 feet, S  $30^{\circ}$ -45' E, 377.65 feet to a F.K. neil at the north corner of Harold D. Young's 13.75 acre tract,

thence following the west line of Young's 13.75 acre tract, S 40°-h0' W, 534.42 feet passing thru the southwesterly right-of-way line of C.R. 153 at 31.65 feet, also passing thru the centerline of the abandoned Toledo and Chio Central Rail-way (previously Bellefontaine & Delaware Railway) at 508.61 feet, to an iron pin in the northeasterly line of Curtis Black's 172.51 acre tract,

thence following the northeasterly line of Black's 172.51 acre tract, said line being 25 fect southwest and parallel with the centerline of the abandoned T. & O.C. Railway, N 34° 54' W, 436.49 fect to an iron pir,

thence N 220-14.5' E, 416.03 feet, passing thru the centerline of the standard T. & O.C. Failway at 29.76 feet, also along the easterly line of the Zanesfield Cemetery to an iron pipe at the southwest corner of the Trustees of Jefferson Township's 0.29 acre tract,

thence following the southerly line of Tevis' 0.34 acre tract, S 75°-15' E, 139.51 feet to a point,



Containing 0.401 acre.






