No. 145 and the west line of the T.R.C.O. property, N 19°-54'-16" E, 1117.09 feet to a R.R. spike in the center of a small bridge, said R.R. spike being the PLACE of BEGINNING,

thence continuing on along said road centerline and the west line of the T.R.C.O. property, N $19^{\circ}-54$ '-16" E, 748.85 feet to an iron pin being S $19^{\circ}-54$ '-16" W, 149.80 feet from an iron pin marking a point of deflection ($\angle = 1^{\circ}-11$ '-22" left) in road centerline,

thence S 56° - 16° - 46° W, 322.17 feet to an iron pin,


thence S 18° -00'-16" W, 403.61 feet to an iron pin,
