## SURVEY FOR HOMER TAYLOR 32.693 Acres January 23, 2007

The following described 32.693 acre tract is situated in the State of Ohio, County of Logan, Township of Jefferson, V.M.S. 4661, V.M.S. 9833, and V.M.S. 10426 & 10427, being all of Homer B. Taylor, etux 32.17 acre tract described in Deed Record 226, page 191, and said 32.693 acre tract being more particularly described as follows:

Beginning at a Ohio Department of Transportation (ODOT) 5 inch concrete monument found in the original north right of way line of former U.S. Route 33 (currently S.R. 292) at P.I. Station 1230+20.10, 30 feet left, as referenced in Logan County Plan L-40, sheet 344, said monument being at an angle point in the south line of said original 32.17 acre tract and marking the place of beginning;

Thence South 86°39'55" West (assumed bearing) 372.60 feet, following the original north right of way line of former U.S. Route 33 and a south line of said 32.17 acre tract, to a 2' by 2' concrete post found at the southeast corner of Gary W. and Charlotte K. Baxter's 3.76 acre tract described in Official Record 237, page 817;

Thence North 04°54′56" East 545.51 feet, departing from the original north right of way line of former U.S. Route 33 and following the west line of said 32.17 acre tract and the east line of said 3.76 acre tract, passing at approximately 223 feet the northwest line of V.M.S. 4661 and the southeast line of V.M.S. 9833, to a 12 inch by 12 inch concrete post found in the south line of Mad River Sanctuary LLC's 98.266 acre tract described in Official Record 849, page 886;

Thence North 84°21'12" East 157.39 feet, following a north line of said 32.17 acre tract and a south line of said 98.266 acre tract, passing at approximately 149 feet the southeast line of V.M.S. 9833 and the northwest line of V.M.S. 4661, to a 3 inch steel post found;

Thence North 59°45'06" East 1217.72 feet, following a north line of said 32.17 acre tract and a south line of said 98.266 acre tract, to a 2 inch iron bar found;

Thence South 81°30'31" East 386.44 feet, following a north line of said 32.17 acre tract and a south line of said 98.266 acre tract, to a 1 inch iron bar found in the west line of Donald H. and Melodie S. Cooksey's 48.12 acre tract described in Official Record 357, page 352;

Thence South 00°54'24" East 692.20 feet, following an east line of said 32.17 acre tract and a west line of said 48.12 acre tract, to an iron pin set;

Thence South 65°00'00" East 229.02 feet, following a northeast line of said 32.17 acre tract and a southwest line of said 48.12 acre tract, to an iron pin set;

Thence South 21°00'00" West 240.24 feet, following an east line of said 32.17 acre tract and a west line of said 48.12 acre tract, to an iron pin set in the original north right of way line of former U.S. Route 33:

Thence South 86°42'16" West 1400.28 feet, following a south line of said 32.17 acre tract and the original north right of way line of former U.S. Route 33, to the place of beginning, containing 32.693 acres, more or less, and being subject to all valid easements and restrictions of record.

Of the above described 32.693 acre tract, 0.993 acre is within the right of way of State Route 292. Of the above described 32.693 acre tract, 0.544 acre is in V.M.S. 9833, 21.927 acres are in V.M.S. 4661, and 10.222 acres are in V.M.S. 10426 & 10427.



DESCRIPTION OF "TRIPLE A" INVESTMENTS PREMISES ON STATE ROUTE #33 IN LOGAN COUNTY BY OCCUPANCY

This survey and description are based on the occupancy of this tract as defined by the location of concrete fence posts as found on December 12, 1974. The deed as recorded in Volume 321, Page 47 does not close by approximately 200° and the prior deed in the chain of Deed Records of Logan County has a reasonable closure but does not fit the conditions as found on the site by occupancy by approximately 10° on one line to 20° on another line.

Situate in the State of Ohio, County of Logan, Township of Jefferson and being parts of Virginia Military Surveys #9833 and #4661 and being described as follows:

Beginning at a 2'x2' concrete post which is purported to be on the intersection of the east line of V.M.S. #3216 (also being the west line of V.M.S. #9833) and the north right-ofway of State Rt. #32 (now State Rt. #33) and in the SW corner of the herein described premises;

Thence along an existing fence line, N 22° 06° 25" E 585.40° to a 0.9'x0.9' concrete post;

Thence along an existing fence line, N 84° 10' 10" E 220.72' to a 0.9'x0.9' concrete post;

Thence along an existing fence line, S 4° 51° 50" W 546.12° to a 2'x2' concrete post in the north right-of-way line of State Rt. #33:

Thence with the north right-of-way line of State Rt. #33, by occupancy, S 87° 00° W 394.13° to the place of beginning and containing 3.76 acres (by occupancy) and being subject to all legal rights-of-way and easements of record.

For purposes of this survey, we assume the concrete post found on the southwest corner as the point of beginning as referred to in Volume 161, Page 506. Also, this is indicated on the State of Ohio map as the approximate line of V.M.S. #9833.
