Beginning at an iron spike found in the center-line of State Route 47 marking the east line of a 10.04 acre tract (Volume 377, Page 8) and lying westerly along said center-line a distance of 509.28 feet from the southeast corner of said 67.71 acres. This beginning point designated as being Station 923+50 in the State Highway records.



SURVEY FOR LARRY PETERSEN 70.133 Acres September 20, 2002

The following described 70.133 acre tract is situated in the State of Ohio, County of Logan, Township of Jefferson, V.M.S. 3441, being all of Larry Douglas Petersen and Jeanne Ann Petersen's 65.96 acre tract described in Official Record 73, page 60, and all of their 1.50 acre Tract I and 2.50 acre Tract II described in Official Record 74, page 669, said 70.133 acre tract being more particularly described as follows:

Beginning for reference at a magnetic nail set in the centerline of State Route #47 (60 feet wide) at P.I. Sta. 928+92.57 as referenced on State of Ohio Right of Way Plans for State Route #47, Project LOG-47, said magnetic nail being in the south line of William H. and Annalee Kotsaris' 33.85 acre Tract 3 described in Deed Volume 230, page 1;

Thence South 83°53'16" West 33.27 feet, following the centerline of State Route #47 and the south line of said 33.85 acre tract, to a magnetic nail set at the southeast corner of said 65.96 acre tract and marking the **place of beginning**;

Thence South 83°53'16" West 509.45 feet, continuing with the centerline of State Route #47 and following a south line of said 65.96 acre tract, passing at 359.28 feet the southeast corner of said 1.50 acre tract, thereafter also following the south line of said 1.50 acre tract, to a ³/₄ inch iron pin found at the southeast corner of Thomas N. Bryant and Valeri A. Hartsock's 10.04 acre tract described in Official 74, page 739;

Thence North 06°07'18" West 756.00 feet, departing from the centerline of State Route #47 and following the west line of said 1.50 acre tract and the east line of said 10.04 acre tract, passing at 29.93 feet a ½ inch iron pin found, also passing at 435.76 feet a ¾ inch iron pin found at the northwest corner of said 1.50 acre tract and at a southwest corner of said 65.96 acre tract, thereafter also following a west line of said 65.96 acre tract, to a 5/8 inch iron pin found;

Thence South 74°07'52" West 627.32 feet, following the north line of said 10.04 acre tract and a south line of said 65.96 acre tract, to a ½ inch iron pin found at the northeast corner of said 2.50 acre tract;

Thence South 05°38'56" East 658.00 feet, following the west line of said 10.04 acre tract and the east line of said 2.50 acre tract, passing at 627.23 feet a ½ inch iron pin found, to a PK nail found in the centerline of State Route #47;

Thence **South 82°38'41" West 167.52 feet**, following the centerline of State Route #47 and the south line of said 2.50 acre tract, passing at 44.65 feet a PK nail found, thereafter entering what was previously described as the 2.50 acre tract but what is herein described as the south line of said 2.50 acre tract, to a magnetic nail set at a southeast corner of Pines Lake, Ltd.'s 77.10 acre Tract II described in Official Record 557, page 250;

Thence North 05°41'16" West 1719.45 feet, following the west line of said 2.50 acre tract and an east line of said 77.10 acre tract, passing at 21.25 feet a ½ inch iron pin found, also passing at 632.44 feet a ½ inch iron pin found at the northwest corner of said 2.50 acre tract and



a southwest corner of said 65.96 acre tract, thereafter also following a west line of said 65.96 acre tract, to an iron pin set;

Thence North 01°06'19" East 1059.22 feet, following a west line of said 65.96 acre tract and an east line of said 77.10 acre tract, to an iron pin set in the north line of V.M.S. 3441, in the south line of V.M.S. 3321, and in the south line of Doris Herrin's 85 acre Tract Two described in Deed Volume 373, page 991;

Thence North 84°40'42" East 1158.95 feet, following the north line of said 65.96 acre tract, the north line of V.M.S. 3441, the south line of V.M.S. 3321, the south line of said 85 acre tract and the south line of Glenn L. Strawser, Gloria Cocaine, and Alice Winebrenner's 132.37 acre tract described in Official Record 81, page 430, to an iron pin set at the northwest corner of said 33.85 acre tract;

Thence South 06°01'42" East 2742.31 feet, entering V.M.S. 3441 and following the east line of said 65.96 acre tract and the west line of said 33.85 acre tract, passing at 2712.31 feet an iron pin set, to the place of beginning, containing 70.133 acres, more or less, and being subject to all valid easements and restrictions of record. Of the above described 70.133 acre tract, 0.466 acre is within the right of way of State Route #47.

The above description was prepared from a field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor #6140, during the month of September 2002. Bearings indicated herein are based on an assumed meridian with all others based on angles turned. Iron pins set are 5/8 inch by 30 inch reinforcing rods with caps marked "CLAPSADDLE RS #6140".



TRACT III: Situated in the State of Ohio, County of Logan, Township of Jefferson and being in original Military Survey No. 3441 and beginning at the southeast corner of John Reames' land; thence north 10 1/2° west to a sugar tree on a hilf. corner to a lot of land sold by J. B. McLaughlin to the said Reames; thence with the south line thereof to its southeast corner; thence north 10 1/2° west to a post in the north line of the original survey; thence north 79 1/2° east 30 poles to a post; thence with the line of John McLaughlin's land, south 10 1/2° east 160 poles to a post in the north line of James Elliott's land and corner to R. McLaughlin's land; thence south 79 1/2° west 80 poles to the place of beginning, containing 60 acres, . more or less.

TRACT IV: Situated in the State of Ohio, County of Logan, Township of Jefferson, and being a part of Survey No. 3441 and beginning at the northwest corner of David Whitehill's land a post in the north line of said survey; thence south 7 1/2° east 71.6 poles to a post; thence with another line of Whitehill's land, south 82 1/2° west 48.6 poles to a sugar tree on a hill (now down); thence north 7 1/2° west 9.4 poles to a post on the west side of a branch; thence north 1/4° west 65.4 poles to a post in the north line of original survey from which a stone at a beech and white oak bears south 82 1/2° east 8,2 poles; thence with said survey line north 82 1/2° east 40.5 poles to the beginning, containing 20 acres, more or less.


