"A", also referenced in field book 706, page 45, as Sta. 195 + 80.59, said iron bar being in the westerly line of said 67 acre and 8 pole tract of land and marking the principal place of beginning;

thence North  $14^{\circ}$  .00' 00" West 3.50 feet, following the centerline of said road, to an iron bar found at a  $19^{\circ}$  53' 20" right deflection angle in said centerline and referenced in survey field book 706, page 43, as Sta. 195 + 84.09;

thence North  $5^{\rm O}$  53' 20" East 173.62 feet, following the centerline of said road, to a railroad spike set;

thence North 80° 34' 00" East 390.27 feet, passing through an iron pin at 31.11 feet set in the easterly right of way line of said road, to an iron pin set;

thence South 9° 26' 00" East 208.71 feet to an iron pin set;

thence South 80° 34' 00" West 432.85 feet, passing through the boundary line between Jefferson and Monroe Townships at 291.95 feet, also passing through an iron pin at 402.76 feet set in the easterly right of way line of said road, to a railroad spike set in the centerline of said road;

thence North 14<sup>0</sup> 00' 00" West 37.89 feet, following the centerline of said road, to the principal place of beginning, containing 2.00 acre, more or less, (1.94 acre in Jefferson Township) (0.06 acre in Monroe Township), subject to all valid easements or restrictions of record.


