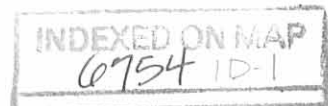

H. 28 S. $20^{\circ} 37' 12''$ W. 67.47 feet to a p. k. nail at the beginning point of this description; thence S. $80^{\circ} 52' 36''$ E. 425.00 feet to an iron bar, passing an iron bar at 51.01 feet; thence S. $9^{\circ} 07' 24''$ W. 308.72 feet to a p. k. nail in the centerline of C. H. 28; thence with said centerline the following 7 courses: N. $62^{\circ} 09'$ W. 112.32 feet to an iron bar; N. $83^{\circ} 33' 09''$ W. 293.52 feet to an iron bar; N. $65^{\circ} 29' 14''$ W. 73.68 feet to an iron bar; N. $39^{\circ} 58'$ W. 61.44 feet to an iron bar; N. $0^{\circ} 48'$ W. 49.35 feet to an iron bar; N. $39^{\circ} 13'$ E. 197.80 feet to an iron bar and N. $20^{\circ} 37' 12''$ E. 6.95 feet to the place of beginning.
