PERMANENT EASEMENT FOR ROAD MAINTENANCE PURPOSES

The following described permanent easement for road maintenance purposes is situated in Virginia Military Survey No. 3326, Jefferson Township, Logan County, Ohio. Said permanent easement being part of a 74.64 acre tract assigned parcel number 12-080-00-00-010.002 which is presently in the name of Carl D. Renkert Etux (O.R. Vol. 537, pg. 837, Tract II). Said easement being more particularly described as follows:

Beginning for reference at a R.R. spike over a stone found in the centerline of T.R. 126 at the centerline of T.R. 127. Said R.R. spike found being a P.I. on T.R. 126 centerline station 50+43 (59+46.46 - stationing this survey) as shown on page 76 of Logan County Engineer's Field Book No. 560.

Thence with the centerline of T.R 126, N. 05° 12' 48" W., 1453.54 feet to a point, said point being centerline station 74+00.

Thence perpendicular to the centerline of T.R. 126, S. 84° 47' 12" W., 20.00 feet to a point on the existing west right-of-way line of T.R. 126. Said point being 20.00 feet left of station 74+00 and being the **true point of beginning** for this easement description.



Thence parallel to the centerline of T.R. 126, N. 05° 12' 48" W., 100.00 feet to a point, said point being 30.00 feet left of station 75+00.

Thence perpendicular to the centerline of T.R. 126, N. 84° 47' 12" E., 10.00 feet to a point, said point being 20.00 feet left of station 75+00 and in the existing west right of way line of T.R. 126.

Thence with the existing west right-of way line of T.R. 126, S. 05° 12' 48" E., 100.00 feet to the point of beginning.

The above described permanent easement for road maintenance purposes contains 1000 square feet or 0.023 acre more or less.








