BETTINGER SURVEY

August 14, 1998

The following described real estate situated in the State of Ohio, County of Logan, Townships of Jefferson and Perry, being part of Virginia Military Survey 5091 and more particularly described as follows:

Beginning at a 5/8 inch iron bar found within the right of way of Township Road 129 at the northeast corner of Michael A. Loverde, et al's 1.994 acre tract as described in O. R. Vol. 120 Page 556.

Thence with said Loverde's north line N. 85° 55' 45" W. 523.23 feet to a 5/8 inch iron bar found, passing a P. K. nail found in the centerline of said T. R. 129 at 13.89 feet, a 5/8 inch iron bar found in the west right of way line of said T. R. 129 at 44.24 feet and the line between said Perry and Jefferson Townships at 472.18 feet

Thence N. 4° 43' 55" W. 252.37 feet to a 5/8 inch iron bar set, passing a 5/8 inch iron bar found at 167.46 feet.

Thence S. 85° 55' 45" E. 518.27 feet to a 5/8 inch iron bar set, passing the line between said Perry and Jefferson Townships at 88.68 feet, a 5/8 inch iron bar set in the west right of way line of said T. R. 129 at 477.84 feet and a magnetic nail set in the centerline of said T. R. 129 at 508.22 feet.

Thence S. 5° 50' 34" E. 253.19 feet to the place of beginning, passing a 5/8 inch iron bar found at 85.19 feet.

Containing 2.982 acres more or less of which 0.242 acre is in the right of way of Township Road 129, 0.400 acre is in Jefferson Township, and 2.582 acres are in Perry Township.

The above described 2.982 acre tract being on the east side of Jerome Bettinger, et ux's 54.2 acre tract as described in D. B. Vol. 318 page 339, Parcel 3, Tract I.

The following described 0.693 acre tract of land is situated in the State of Ohio, County of Logan, Township of Jefferson, and V.M.S. 5091, being part of Donald W. and Krista A. Jackson's 5.709 acre tract described in Official Record 1138, page 957, and said 0.693 acre tract being more particularly described as follows:

Beginning for reference at a 5/8 inch iron pin found with cap marked "BLACKBURN RS 7873" in the centerline of Township Road 129 at a Point of Intersection Station 117+06.5 as referenced in Logan County Engineer's Field Book 682, page 12;

Thence South 0°58'49" East (assumed bearing) 625.31 feet, following the centerline of Township Road 129, to a magnetic nail found at the northeast corner of said 5.709 acre tract and at the southeast corner of Rodney A. Bair's 5.785 acre Tract III described in Official Record 1015, page 617;

Thence North 85°03'29" West 788.84 feet, departing from the centerline of Township Road 129, following the north line of said 5.709 acre tract, and the south line of said 5.785 acre tract, passing at 30.13 feet and at 472.33 feet, 5/8 inch iron pins found with caps marked "BLACKBURN RS 7873", to an iron pin set and marking the *place of beginning*;



Thence **North 4°49'44" West 88.00 feet**, following the west line of said 5.709 acre tract and V.M.S. 5091, and following the east line of said 68.350 acre tract and V.M.S. 2674, to a 5/8 inch iron pin found with cap marked "BLACKBURN RS 7873" at the southwest corner of said 5.785 acre tract;

Thence **South 85°03'29" East 471.00 feet**, entering V.M.S. 5091, following the north line of said 5.709 acre tract and the south line of said 5.785 acre tract, to the *place of beginning, containing 0.693 acre*, more or less, and being subject to all valid easements and restrictions of record.
