Beginning at a railroad spike found at the intersection of center-lines of County Highway 11 and County Highway 18.

THENCE, with the center-line of County Highway 18, S 3°-02'-53" W, a distance of 546.00 feet to a PK Nail set at the TRUE POINT OF BEGINNING.

THENCE, with the center-line of County Highway 18, S 3°-02'-53" W, a distance of 224.00 feet to a PK Nail set.

THENCE, N 85°-08'-49" W, a distance of 674.41 feet to a 5/8 inch iron rod set.

THENCE, with the east line of the James Mast original 50.0 acre tract (O.R. 114, Pg. 278), N 5°-50'-36" E, a distance of 223.92 feet to a 5/8 inch iron rod set.

THENCE, S 85°-08'-49" E, a distance of 663.49 feet to the point of beginning.

Containing 3.438 acres of which 0.154 acre is within the highway right-of-way.

The basis for bearings is based upon the center-line of County Highway 18 being S 3°-02'-53" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on November 14, 1994.





Thence N. 87° 09' 20" W. 217.82 feet to a 5/8 inch iron bar set.


