Thence **North 82°19'33" West 268.98 feet** to an iron bar set in the east line of said 80.560 acre tract and in the west line of said 19.53 acre tract;

Thence North 05°27'36" West 477.75 feet, following the east line of said 80.560 acre tract and the west line of said 19.53 acre tract, passing a 16 inch concrete post found at 461.72 feet, to the place of beginning, containing 3.201 acres more or less and subject to all valid easements and restrictions of record.

The road right-of-way of Township Road 219 (40 feet wide) contains 0.029 acres more or less.


