BRUBAKER TO AMERICAN POSTAL AUTHORITIES

Lying in the Village of Lakeview, Section 34, T-6-S, R-8-E, Stokes Township, Logan County, Ohio.

Being that same 40 foot lot remaining of that land in the name of Kathryn L. Brubaker as deeded and described in Volume 210, page 53 (TractII) and being more particularly described as follows:

Beginning at a drill hole in the edge of a concrete sidewalk marking the southeast corner of the Brubaker lot and being the northeast corner of the Walters 0.40 acre lot (Volume 372, Page 652), being on the west line of South Main Street, northerly, with said west street line. a distance of 109.01 feet from the north line of Harrison Street.

THENCE, with the north line of said 0.40 acre lot, S 89°-51' W, a distance of 157.30 feet to a 1/2" iron rod set on the east line of a 14 foot wide alley.

THENCE, with said east alley line, N 0°-21' W, a distance of 40.00 feet to a 1/2" iron rod set on the southwest corner of the Cummins 0.22 acre lot (Volume 403, Page 753).

THENCE, with the south line of said 0.22 acre lot, N 89°-52' E, a distance of 155.67 feet to a drill hole in concrete at the west line of South Main Street.

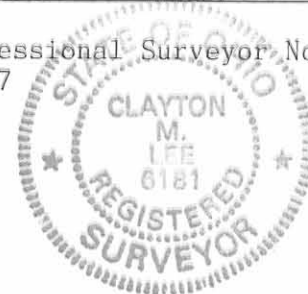
THENCE, with said west street line, S 2°-14' E, a distance of 40.00 feet to the point of beginning.

Containing 6256.3 square feet (0.144 acre).

Basis for bearing = Center-line of Main Street (S 2°-41' E).

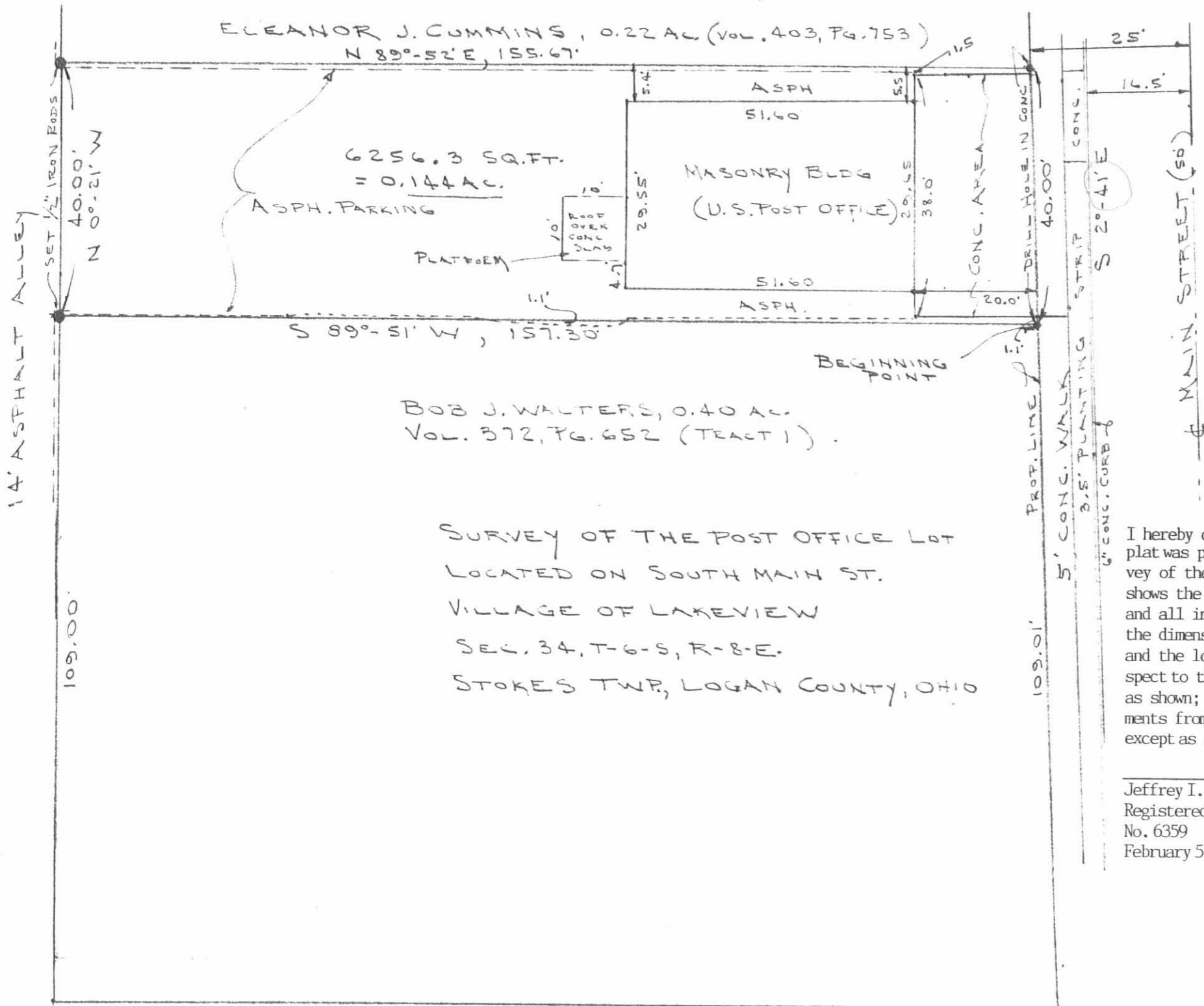

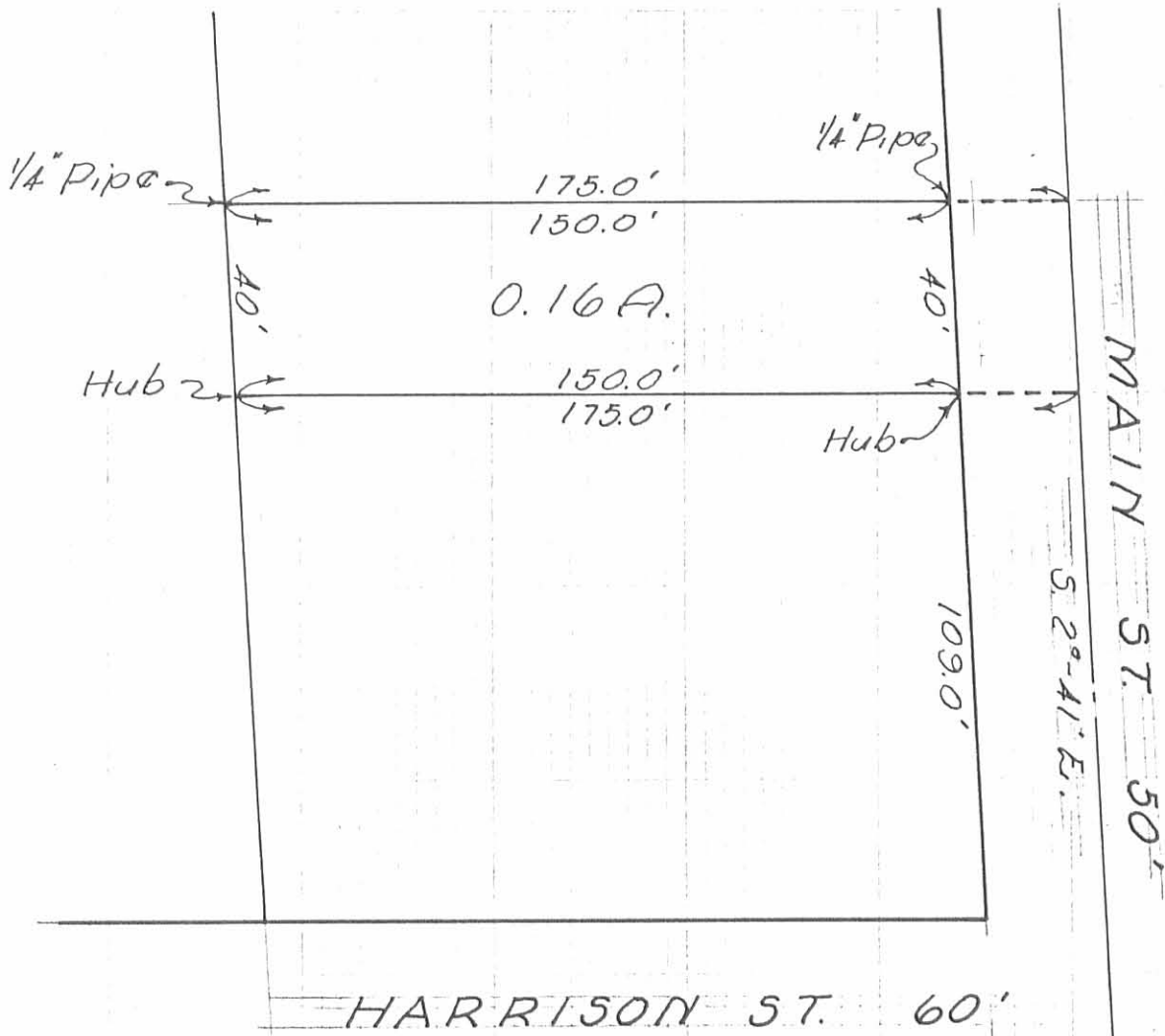

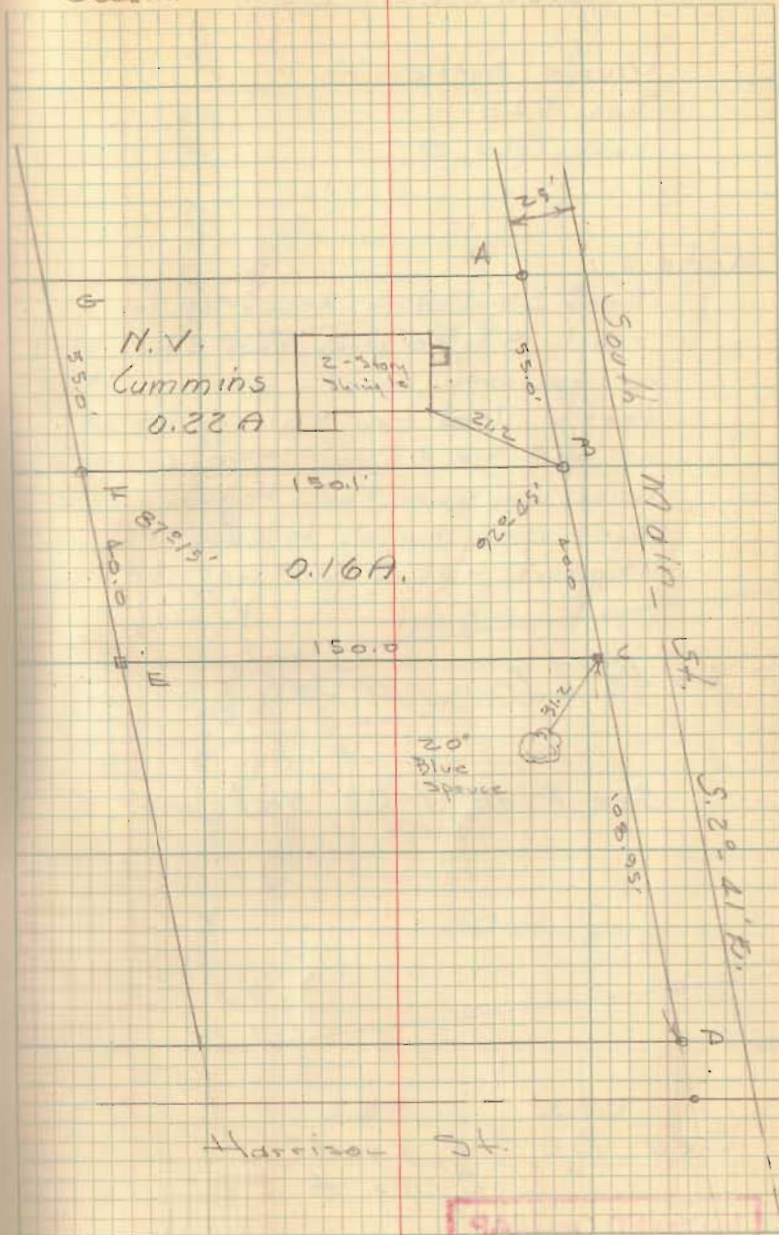
